COMPUTER ACCESS AND MEDIA RELEASE

Please review all school information, policies and procedures located on the District website. Please sign or initial, as appropriate, **ON THE FRONT AND BACK OF THE TWO SIDED CONSENT FORM** and return that document to the school office by no later than Tuesday, September 3, 2019. The return of that form with completed signatures is required for a student to receive computer access. Signing of that form signifies your understanding and agreement to all the policies outlined in the District Code of Conduct, as well as the Computer Acceptable Use Policy.

AGREEMENT FOR STUDENT USE OF DISTRICT COMPUTERIZED INFORMATION RESOURCES

In consideration for the use of the School District's Computer System (DCS), I agree that I have been provided with a copy of the District's policy on student use of computerized information resources and the regulations established in connection with that policy. I agree to adhere to the policy and the regulations and to any changes or additions later adopted by the District. I understand that failure to comply with these policies and regulations may result in the loss of my access to the DCS. Such violation of District policy and regulations may also result in the imposition of discipline under the District's conduct and discipline policy and the Student Discipline Code of Conduct. I further understand that the District reserves the right to pursue legal action against me if I willfully, maliciously, or unlawfully damage or destroy property of the District. Further, the District may bring suit in civil court pursuant to General Obligations Law Section 3-112 against my parents or guardians if I willfully, maliciously, or unlawfully destroy District property.

Parental / Guardian Consent:

I am the parent /guardian of the minor student who has signed the District's Agreement for Student Use of Computerized Information Resources. I have been provided with a copy and I have read the District's policy and regulations concerning use of the DCS.

I also acknowledge receiving notice that, unlike most traditional instructional or library media materials, the DCS will potentially allow my son/daughter student access to external computer networks not controlled by the District. I understand that some of the materials available through these external computer networks may be inappropriate and objectionable; however, I acknowledge that it is impossible for the District to screen or review all of the available materials. I accept responsibility to set and convey standards for appropriate and acceptable use to my son/daughter when using the DCS or any other electronic media or communications. I agree to release the School District, the Board of Education, its agents, and employees from any and all claims of any nature arising from my son/daughter's use of the DCS in any manner whatsoever. I agree that my son/daughter may have access to the DCS and I agree that this may include remote access from our home.

RELEASE FOR STUDENT INTERVIEWS, PHOTOGRAPHS, AND VIDEOTAPES

I hereby consent that interviews, photographs, and/or videotapes of my child may be taken or used by the District only for public relations, educational, or other purposes consistent with the purpose and mission of the District, including publication on the District website. I further understand that this Release applies to all District events, including, but not limited to, educational, extracurricular, athletic, and performing arts events. I further agree that said material shall become the property of the District, and I hereby release and discharge the District and its representatives from any and all claims that may arise by reason of taking of said interviews, photographs, and/or videotapes. I also understand that my child's first and last name may be used for public relations, educational, or other purposes by the District.

OUTSIDE NEWS MEDIA RELEASE FORM

I give permission for my child to be interviewed, photographed, and/or videotaped by outside news media representatives for press or media print or broadcast purposes as indicated above. I further understand that this Release applies to all District events, including, but not limited to, educational, extracurricular, athletic, and performing arts events. I further agree that such material shall become the property of the applicable media agency, and I hereby release and discharge the District and its representatives from any and all claims that may arise by taking of such interviews, photographs, and/or videotapes.
