

Governor Cuomo has extended closure through the remainder of the academic year. Please understand that this closes school buildings, but remote learning continues through June for all students to the end of our fourth marking period.

We are still waiting to hear about the possibility of summer school, and whether we will be allowed to hold an in-person graduation ceremony for the Class of 2020.

Here is the summary as of Monday, May 4, 2020 NEXT PLANNED UPDATE—MONDAY, MAY 11

An Executive Order issued on Friday, May 1 mandated that school budget votes across the state will take place by mail-in ballots only, counted on June 9. We are working through the details of this order, and more information will be communicated in the weeks to come.

- Postcards will be sent to district residents in early May to outline the regulations for this vote.
- The district will attempt to send a ballot, with a stamped return envelope, to each eligible voter, but we know that some voters will be missed, because no complete list of eligible voters exists (this is true across the state). If a voter does not receive a ballot but wants one, he or she should contact the district clerk at sreynolds@southseneca.org or by phone at 869-9636, extension 4147. Please wait for the initial set of ballots to be sent, arriving near May 30.
- The ballot will include four items for voting:
 - o Should the community accept the 2020-21 expenditure budget for the school district?
 - Should the community accept collection of taxes to support the funding of our public libraries?
 - o Should the community allow the district to access bus reserve money to purchase buses?
 - Who should be elected to serve three year terms on the board of education? (there are three board member terms expiring on June 30, so three members will be elected)

Walkers and runners may continue to use the track in Ovid, but we ask PLEASE that anyone on the track follow proper social distancing guidelines from the Seneca County Health Department.

• Unfortunately, though, we do need to close the playgrounds, and tennis and basketball courts (any of our spaces where specific pieces of equipment are shared). We will open these areas again when it's safe to do so.

The Board of Regents, at their April meeting, announced that June Regents Exams will be cancelled this year. On April 30, they also announced that August Regents Exams are cancelled:

Modifications apply to all students enrolled in grades 7-12 during the 2019-20 school year who were intending to participate in one or more of the June 2020 Regents Examinations.

Students who, during the June 2020 examination period would have taken one or more Regents examinations, will be exempted from passing the assessments in order to be issued a diploma. To qualify for the exemption, students must meet one of the following eligibility requirements:

- The student is currently enrolled in a course of study culminating in a Regents examination and will have earned credit in such course of study by the end of the 2019-20 school year; or
- The student is in grade 7, is enrolled in a course of study culminating in a Regents examination and will have passed such course of study by the end of the 2019-20 school year; or
- The student is currently enrolled in a course of study culminating in a Regents examination and has failed to earn credit by the end of the school year. Such student returns for summer instruction to make up the failed course and earn the course credit and is subsequently granted diploma credit in August 2020; or
- The student was previously enrolled in the course of study leading to an applicable Regents examination, has achieved course credit, and has not yet passed the associated Regents examination but intended to take the test in June 2020 to achieve a passing score.

Plans during closure:

- Please continue to look for communications from teachers as we provide home-based continuity of learning
- The goal is to maintain one-to-one connection of students to school adults, no matter how long this closure period lasts
- High School students are the only students in the New York State system who are in credit-bearing courses, so they will be asked to work on assignments that may be graded
- For PK-8 students in non-credit bearing classes, teachers will be providing short narrative
 reports about academic progress during closure. These will be sent at the beginning of May and
 at the end of June. Near May 1, we will issue 'comment only' report cards for high school
 students. Some time later in the school year, all students in credit bearing classes will have
 grades reported for those classes, so we can issue credits locally. Look for more information on
 that in the month of May.
- For Elementary and Middle School students, the objective is preserve the continuity of learning as much as possible, and materials and resources are designed to engage and to deliver course content
- Our first priority is to know everyone is tending to their well-being and safety. Please do not hesitate to reach out to the district if you have particular needs, or if your situation has changed
- Academically, we hope each of our students is able to find materials to stay engaged in meaningful learning, each day of our school year. We don't want this to be a burden—we encourage taking breaks, spacing the work out, and communicating to us when it feels like too much
- All families should become familiar with our plans to make free meals available (see below).
- Some families are concerned about mental health supports, and we share that concern. We will be
 doing everything in our power to make plans to support students and families during the closure
 period, and we will work with anxious families to establish a plan.
- Our Special Education department is working hard to account for essential services. We must accept
 that there will be challenges ahead, and we are committed to doing what is in our power to maintain
 essential services.

Please follow all NY Pause directives to keep everyone safe:

- It is vital to understand the objective is for families to stay home as much as possible and to avoid public gatherings of any size unless necessary.
- If you need to be out in public and interacting with others, wear a mask.
- Wash hands regularly and thoroughly
- Avoid those who are sick

Avoid covering coughs and sneezes with hands

Plan for access to meals during an extended closure:

- Preparation of bagged food in Ovid building
- We are doing individual home delivery of all meals, instead of doing pickup locations in the district. A driver will deliver meals to your door if you need them. Delivery times will be Monday, Wednesday, and Friday, mostly between 11am and 1pm. Please secure your animals during meal delivery times.

Each day of delivery, we will provide enough meals to last until the next delivery date.

• In addition to our meal distribution, we will share other food distribution programs we know are happening. Here is information from the Ovid Federated Church:

Adjusted policies in effect as of Monday, March 16:

- Limited use of building for non-essential staff
- No use of building by outside groups until further notice
- No Extended Day program until further notice
