## Recommendations of the Superintendent of Schools:

a) During the period of expulsion, the Board will provide Student 2019-2020-01 with an alternative educational program, which shall be defined by Section 10-74j of the Connecticut General Statutes and deemed appropriate by the Administration.

If student 2019-2020-01 becomes ineligible to attend the Watertown Public Schools pursuant to Board Policy and/or if the Parents withdraw student 2019-2020-01 from enrollment as a student, the Board will have no obligation to provide student 2019-2020-01 with the alternative educational opportunity describe herein.

- b) During the period of expulsion, student 2019-2020-01, will not be permitted to be on school grounds and will not be permitted to attend or participate in any school-sponsored activities except as authorized in writing in advance by the Superintendent of Schools.
- c) The Superintendent of Schools will review student 2019-2020-01's conduct and compliance with this Agreement as well as participation, effort level, attendance, and academic performance in the alternative educational program. It is the Superintendent's sole discretion, whether student 2019-2020-01 be readmitted to Watertown Schools on or about March 11, 2021.

**Motion made by Mr. Lambert and seconded by Ms. Wilk:** I make a motion to accept the Stipulated Agreement entered into between the Administration and the family, as amended by the Watertown Board of Education.
