The regular meeting of the Board of Education, White Salmon Valley School District, Klickitat and Skamania Counties, White Salmon, WA was called to order at 7:00 p.m. Thursday, November 21, 2019 in the Columbia High School Library, located at 1455 NW Bruin Country Rd., White Salmon, WA. Present: Vice Chairman David Karlson, Andrea VanSickle, Paul Mosbrucker, Chairman Alan Reitz (via telephone), Supt. Jerry Lewis, and guests.

White Salmon Academy teacher, Amy Steunenber, along with several WSA students presented to the board. Amy introduced herself and her students, and thanked the board for their ongoing support. Amy spoke to the board about the unique schedule and opportunities the school is able to provide to their students. Each student then shared their stories and experiences, and why the White Salmon Academy is a good fit for them. Students shared the success that they have had while attending WSA. They also shared their goals and future plans. Brian Morris introduced Kay Alton, who spoke to the board about the support she is able to provide while working with the students. The presentation ended with a slide show, documenting many projects and moments for the students. The board enjoyed the presentation and thanked the students.

Andrea VanSickle moved to accept the Consent Agenda, general fund bills including checks 49477 through 49610, totaling \$149,655.33, checks 49632 through 49650, totaling \$28,528.75, and check 49653 totaling \$2,798.05. ASB fund checks 49611 through 49628, totaling \$4,709.24. Capital Project checks 49629 through 49631, totaling \$8,357.19 and checks 49651 through 49652, totaling \$63,230.16. Electronic deposits to the Department of Revenue of \$3,535.71, \$2.24, \$2,497.17, \$121.42, and \$1,897.73. Payroll checks 49654 through 49723 including electronic deposits and payroll tax in the amount of \$1,160,774.32. Seconded by Paul Mosbrucker. Carried.

Audience Comments:

Audience comment was given by: Gabriel Gilbert.

Reports:

- a) **ESD 112 Regional Superintendent 2020 Legislative Priorities:** Dr. Lewis shared information highlights from the November 15th meeting that he attended.
- b) **Enrollment Report:** Dr. Lewis updated the board on the month's enrollment. Enrollment for November dropped by 4.33 FTE, leaving the district below the projected budget.
- c) **District Instruction and Learning:** Dr. Lewis shared that the High School is in the process of re-accreditation this year. Craig McKee, the CHS Principal, talked about the process. Dr. Lewis has met with the ESD communication department to continue work on the district safety communication plan, and hopes to share with the board next month. Rhonda and Jeff are continuing to work on the mass-communication application. Dr. Lewis shared that each building is working on the implementation of their school improvement plans.
- d) **Bond Projects Update:** Dr. Lewis met with the installers of the covered play areas on Monday. The structure materials should be arriving mid-January. The design process is moving along on the multi-purpose facility and portables.
- e) **Pool Property Lease:** Both parties' attorneys are working on the lease language and negotiation. The Parks Board is hoping to finalize by the December board meeting.
- f) **Employees of the Month:** Employees of the month for the month of October were: Baylee Fox, Whitson Elementary School, Shelley Wilson, Wallace and Priscilla Stevenson Intermediate School, Ashley Howe, Henkle Middle School, and Jose Maya, Columbia High School. The board gave them a round of applause.
- g) **Volunteer Hours:** Volunteer hours for the month of October were: 287.5 hours at Whitson Elementary, 104.75 hours at Wallace and Priscilla Stevenson Intermediate, 111.5 hours at Henkle Middle School, and 153 hours at Columbia High School. The hours for the month totaled 656.75 with an annual total of 886.45 volunteer hours. The board thanked the volunteers.

- e) **New Hires:** Andrea VanSickle moved to approve the hiring of Maria Quintana, CHS Bilingual Paraprofessional, Candy Fetsch, CHS Girls Basketball Assistant Coach, and Brandon Ellsworth, District Custodian. Seconded by Paul Mosbrucker. Carried.
- f) **Board Resolution No. 19/20-05: Authorizing Participation in the National Purchasing Cooperative:** Paul Mosbrucker moved to approve resolution 19/20-05. Seconded by Andrea VanSickle. Carried.

At 7:53 p.m. Vice Chair David Karlson announced the board would adjourn to executive session for fifteen minutes to discuss personnel per RCW 42:30.110(g), and that no action will be taken upon their return. The board reconvened to open session at 8:08 p.m.

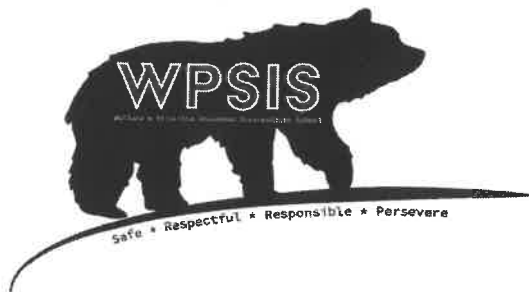

Report to the School Board, December 2019
Wallace and Priscilla Stevenson Intermediate School

Late November and December is an infamous time of year in the education system- this is when it all happens at once and if things are working smoothly it's great, but one hitch in the rhythm and it all goes downhill fast. Students are finishing large projects as the term ends, grades are due, students are worried about leaving school for two weeks, indoor recess starts up in bad weather, and it is tough to keep up. Here at WPSIS, this is a highly productive time- kids are in the groove, we know them well enough to help them meet their needs and reduce anxiety, they are able to focus and show us what they've been learning and it looks like great progress. In fact, I was interrupted in writing this paragraph by a student who wanted to brag that he met his first chapter goal in math this year, way to go Wyatt and Mrs. Pfister!

Adding to it all, we hosted Breakfast and Books on November 16th, and doubled the turn out from last year! We had more than 250 attendees; each child received a free book and a prize if they took a parent on the Kodiak Quest, a curriculum based scavenger hunt that directly involves the parents with the materials and topics from class. Another popular booth was just playing the math based games that we play every Wednesday. Involving parents in playing and giving out rules and materials will hopefully lead to those games being played at home, engaging kids in math practice at home to reinforce basic skills they need in class. We specifically targeted the students who receive Title 1 services based on the rank-order of academic performance and had a much better turn out from that group of families than last year- a major win for us and a great way to increase family engagement as required by the Title 1 grant. Thanks to Megan Sheffels, Ashleigh Coyner, Samantha Cooper, Karynn Campbell, and Christian Morris for putting it all together.

Now that we gave away books and know everyone has something to read, we launched a Winer Reading Challenge. The hot-cocoa based challenge creates a class based competition on the number of minutes spent reading or listening to a book to encourage them to read over winter break. All participants get a cup of hot cocoa when they return and the winning grade level gets an extra recess. We launched it all with a pajama-day flashlight reading party, with an hour of the Trimester end half day getting cozy and reading in each class, and kids are turning in minutes already (4th grade is in the lead with 2,500 minutes read). Staff is participating as well and we are currently engaged in a book study of 'Blindspot' and will be catching up soon. 'Blindspot' is an exploration of the 'hidden bias of good people', with the idea that everyone has bias and the only way to mitigate personal bias is to first recognize it. We had great discussion at our first meeting and this study should directly lead to personal and systemic changes that will align directly with our district goal on increasing equity.

The School Improvement Grant that comes from OSPI and OSSI includes several leadership coaches, two of them new to us and to the program this year. Scot Embry was a highly regarded principal south of Olympia who is specifically noted for creating Multi-Tiered Systems of Support (MTSS) that led to increased performance for the whole school and specifically in SPED- an area in which we are targeted for improvement. We will be working together along with our intervention staff at WPSIS and Whitson to strengthen our support for any child who needs more support academically or socially. The Admin team has attended MTSS training this year as well, there is support from OSPI statewide for these programs. John Shultz is a Science consultant, which is a new area of support for OSSI. He will be working with my staff to formalize our science teaching based on standards and topics covered, and help us align our materials from ESD 112 to the new standards. The ESD says they did that for us, but we can't see any evidence that they did. Luckily we have a great staff and John to help us.

I want to thank both Rita Pinchot and Caitlin Cray for going to the training and helping to implement the mental health pilot study. I also want to thank Dr. Lewis, Deb Drandoff, and Rita Pinchot for all their work on the application process.

Drug and Alcohol Counselor

Rita Pinchot, who has been working with our students on drug and alcohol prevention, has started Intervention groups in both the High School and Middle School. She has also completed the 9th-grade Prevention Ed series for fall semester health classes.

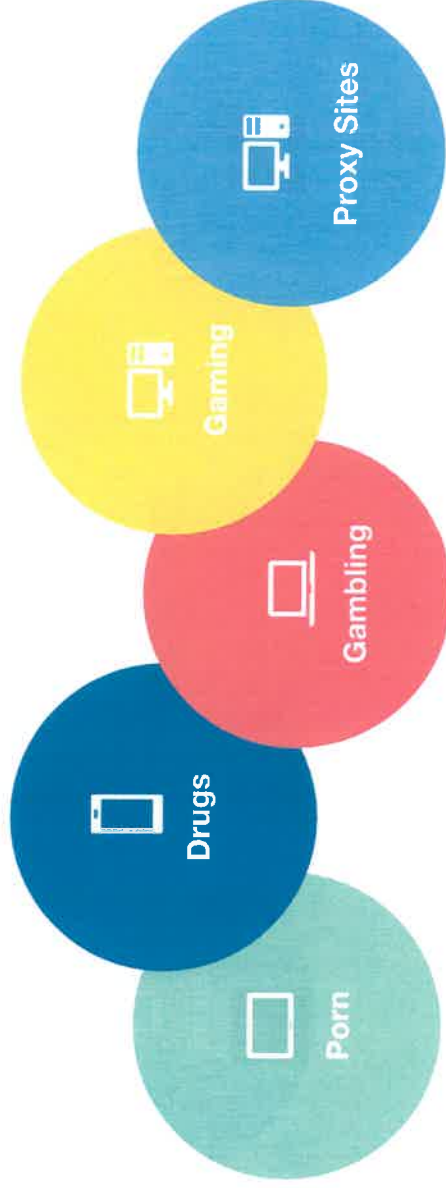

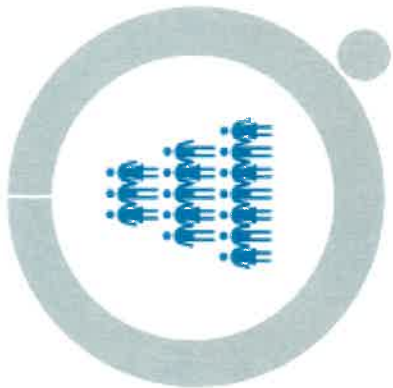

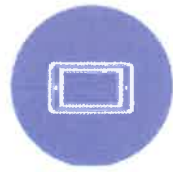
