- Board President Olson reported he had balanced the check book with Jolene; will have a "zoom" meeting with 3-Rivers Cooperative for the next 3 months.
- Superintendent Halverson reported on the flex learning and the upcoming waiver; scheduling and planning is being done for next year; we have an Ag. Education instructor and MS/HS School Counselor position openings; prom has a tentative date set for June 6, graduation is an agenda item, Principal's Redden and Pierson are working on ideas for academic awards and athletic awards for the students; the building update/schedule is as follows: the building site is staked out, on Friday Puetz will be moving in some equipment, gravel will start to be hauled in and piled on the North lot of the football field, ACTION will begin next week.
- Middle School Principal/AD Pierson reported that they are sending out 85 packets while 12 students remain online, the positive's that they are seeing is much more communication with families, the teachers are adapting to the change well, and the staff attitudes are staying very positive, we see this experience will change our approach to education. On the athletic side of things Principal Pierson is working out a process to get the winter athletic awards to the students, and he is encouraging coaches to reach out to their athletes to communicate and push the kids to stay as active as possible.
- Secondary Principal Redden reported that the flex learning is distributing 112 packets and 38 online, the communication with parents is very good, they have been very understanding, they have questions about procedures and they have been supportive of the teachers efforts; communication with the staff includes weekly zoom meetings and it is great to see everyone together; they have sent out progress reports with incomplete list of assignments and letters to parents explaining the importance of the assignments.
