I. CALL TO ORDER

The meeting was called to order at 7:02 p.m. by Sean Nicholson.

Chair Nicholson read the following statement: Consistent with the Massachusetts Open Meeting Law MGL Ch. 30A, S. 20 and Regulation 940 CMR 29.10, which allows for remote participation in certain circumstances under the Massachusetts Open Meeting Law Regulations, the Mendon-Upton Regional School Committee will be conducting this meeting remotely. In this particular case, all six members of the Committee are participating remotely and virtually through videoconferencing. This is consistent with Governor Baker's Executive Order of March 10, 2020, which eased the requirements of having a meeting in a physical space open to the public and having a quorum of the Committee physically present. Any and all votes will be conducted by roll-call votes. Per usual, this meeting will also be livestreamed and recorded.

II. NEW BUSINESS

Presentation of Revised FY2021 Operational Budget

Dr. Maruszczak presented a revised FY2021 operational budget due to the COVID-19 crisis:

- Recertification would be \$1,827,627 less than the amount certified on 3/9 due to FY20 savings and lesser requests
- Items for savings include supplies, heat, snow removal, substitute teachers, maintenance OT; Workers Comp; Athletic Transportation; misc accounts; Regular Transportation and SpEd Transportation

- Reduction include eliminate 4 FTE from the original request, level fund supply
 accounts, no technology refresh, regular transportation in negotiation,
 increase school choice appropriation, salary/COLA for all employees –
 reflective of crisis utilize savings from FY20 to offset FY21
- Assumptions: state funding will be *level* to FY20; Local operational assessment for Mendon will be \$10,197,621 which is a decrease of \$773,214 and Upton will be \$12,223,378 which is a decrease of \$969,436
- This is reflective of the economic situation at this point and requesting a large override would not be in the best interest for our communities.
- Increase to Mendon is \$521,820 and \$250,00 will be within prop 21/2 level limit and \$271,820 for override
- Increase to Upton is \$502,261 which is \$300,000 from within prop 2 1/2, and \$200,000 override
- Based on an average home value of \$425,000, tax impact in Mendon 114.49/year and for Upton 71.58/year
- Dr. Maruszczak recommends to move forward with this strategy
- It was noted Upton would be discussing new budget on Thursday and Mendon would be discussing it today.

Recertification of FY2021 Operational Budget

Shelley Cook: Looking for line items subtotal for the modifications. Dr. Maruszczak stated it will be available on website this afternoon.

Paul Flaherty asked about the roll over money from FY20. Jay Byer stated it will be put into School Choice and the funds will be used out of school choice to fund FY21. The amount is estimated to be \$680,000

Paul Flaherty asked if there will be an override next year – Dr. Maruszczak stated the recertified budget takes in account extraordinary circumstances and we may be in the same position next year. Communities will still need to be responsible for the MURSD budget and the needs will still be there in the future. School Committee and district is recognizing the crisis and the implications to the communities. Next year, it is unknown what will happen. It is a reduced request that represents sacrifice by all stakeholders such as employees and the savings realized by having the school being closed for 1/3 of the year. Sean Nicholson emphasized the sacrifice being made to keep the district operational and it needs to be recognized.

Shelley Cook asked if in the new budget, has cuts been made in travel area, such as dues, conference and travel? Dr. Maruszczak stated professional developmental lines have been level funded. These are district wide expenses and dues to the various associations.
