- 12. Perform emergency cleanup resulting from breakage, vandalism, spills and illness. E
- Lock/unlock gates and doors, secure buildings/grounds and set alarm systems. E
- 14. Assist in receiving, assembling and distributing supplies and equipment. E
- 15. Raise and lower flags.
- 16. Perform minor maintenance tasks in keeping assigned areas safe and operational.
- 17. Serve as substitute for daytime custodian.
- 18. Occasionally perform routine ground maintenance functions.
- 19. Checks and refills towels, toilet paper and soap dispensers. E

WORKING CONDITIONS
