I. Call to order:

Mr. Simpson called the meeting to order at 7:33 P.M.

II. Visitor's Comments:

Any citizen wishing to speak before the Committee must sign in with the Administrative Assistant prior to the opening of the Regular Session of the School Committee. The visitor will identify themselves by name and address and shall speak for no longer than three (3) minutes. (See Granby Public School Committee Policy BEDG).

The visitors of the evening spoke out regarding any upcoming educational funding. If there were any cuts due to lack of funding then it was expressed that these cuts not affect the student population. A visitor asked if Granby was involved in the Peer/Student engagement that was put forth by DESE recently as well as a non-resident policy regarding residents who were not living in Granby be able to participate in school committee meetings. A visitor also asked if school committee was involved with the wellness Wednesdays in Granby Public Schools. It may be difficult for some students to stop mid-week and then resume studies again on Thursday and Friday.

III. Student Representative Report: Marcus Baran

Mr. Baran sent a questionnaire to students regarding the COVID-19. A PowerPoint was provided. He asked about the workload, difficulty and teacher accessibility and assistance.

IV. New Business

A. Transportation Cost Comparison: Mr. Tarquini

There were negotiations regarding Van Pool and First Students payments during the pandemic. Granby, Belchertown and Ware share a contract with First Student. Granby will pay 42% of the amount due for the remainder of the school year. Van Pool will receive 78% payment for the remainder of the school year. This agreement has not been voted on and is not finalized at this time.

- B. Refunds for spring user fees: Ms. Jordan
 Granby is a pay to play school district. Roughly 70 student athletes signed up for a
 spring sport however on April 24th the spring season was cancelled. Refunds will be
 given to all who signed up for a spring sport.
- C. Spring Sport coaching payments: Ms.Jordan Spring coaches will be paid a 15% of their coaching stipend for the spring season. Coaches attended pre-season meetings and spend time planning for their season and practices.
- D. Potential Impacts of COVID-19 to education, facilities, budget
 Ms. Mallette will be looking at the requirements to derive a joint resolution with CES
 and possibly other school districts that could be sent to the state asking for an
 increase in aid. On March 15th the district move to remote learning and the buildings
 were closed. There are still Professional Development offering to teachers and
 paraprofessionals. There will be some aid for the Chromebook firewall protection that
 was needed for the students to be able to take them home for remote leering. There
 is a running list of other items that could possibly be reimbursed as well. There is a
 municipal spending freeze however Granby is working with the town to cover the
 asbestos abatement payment for room 110. There is a possibility of changes for
 School year 2020-2021 regarding remote learning due to the pandemic.
- E. Signing Warrants Electronically

The school committee voted a few years back regarding a policy Municipal Modernization where the school committee/superintendent could have a designee sign the warrants for bills and payroll. Prices are being researched for digital signature software.

MOTION: Mr. Evren motioned to designate the school committee chair or his designee to sign the warrant and electronically sign when the software is purchased, seconded by Mr. Pietras
