RECOGNITION

The Board

- gave the Old Bridge Police Department and Police Benevolent Association, Local 127, the opportunity to recognize and commend seven students who participated with the COPS for Kids Holiday Party. SUPERINTENDENT OF SCHOOLS

David Cittadino

- reported to the Board of Education on the incidents of violence and vandalism, which have occurred in the district during the previous school year (January through June 2015).
- said the following counts of incidents by reporting category are: violence, 29; vandalism, 5; weapons, 2; substance abuse, 17; and unduplicated total 69.
- said the cost of vandalism to the district for the reporting period of January through June 2015 was zero.
- said actions taken were: police notified (no complaint), 8; police notified complaint filed), 8; in-school suspension, 10; out-of school suspensions, 64; and expulsions, unilateral removals, removals by ALJ, 0.
- said there were 77 student offenders; 37 student victims; 9 school personnel victims; and 0 student victims of violent criminal offense.
- said there were 16 HIB (Harassment, Intimidation, and Bullying) incidents, including 7 for race; 2 for color; 1 for religion; 4 for sexual orientation; 3 for mental, physical or sensory disability; and 2 for other distinguishing characteristics.

- said the mode of HIB incidents included 16 verbal; 2 physical; and 3 electronic communication.
- said the disciplinary action taken included: other/none, 19; expulsion, 0; in-school suspension, 5; out-of-school suspension, 5; detention, 3; suspension of privileges, 5; individual counseling, 17; and restitution and restoration, 2.
- offered a year-to-year comparison of district reporting of violence and vandalism. He said the number of violence, vandalism, weapons, and substance abuse incidents totaled 180 in 2011-2012 compared to 108 in 2012-2013; 75 in 2013-2014; and 78 in 2014-2015.
- said the number of confirmed HIB incidents decreased from 58 in 2011-2012 to 22 in 2012-2013; 35 in 2013-2014; and 24 in 2014-2015.

PROGRESS TOWARDS GOALS

Jeffrey Caulfield, supervisor assessments/guidance

- presented the district's annual testing report. He addressed PARCC (Partnership for Assessment of Readiness for College and Careers), which replaced the HSPA (High School Proficiency Assessment) and previous assessments; the PSAT, which was administered to freshmen at the high school on Oct. 14; SAT historical data; and AP testing results.
- said the district received the results of the PARCC in December for nine grade levels in ELA and mathematics.
- said Old Bridge out-performed the state in 11 out of 18 areas. He said the state recommends districts to use the first year of data as baselines.
- said in grades 3-5, Old Bridge out-performed the state in all areas in ELA and mathematics.
- said it received a grade analysis by school and how each grade level preformed compared to the State of New Jersey.
- said OBHS has demonstrated significant growth on the PSAT in all areas over the past five years. Next year all four classes will have taken the PSAT as freshmen.
- said a high percent of AP students received scores of 3 or more.
- said in 2011, 160 students took AP exams compared to 360 in 2015.
