WHEREAS,	The Anti-Bullying Bill of Rights, Assembly Bill 3466, was approved by the New Jersey Legislature in November 2010 and signed into law as P.L. 2010, c. 122, by
WHEREAS,	Governor Chris Christie on January 5, 2011; and The statute is intended to protect students from harassment and intimidation that would substantially interfere with their education; and
WHEREAS,	The Anti-Bullying Bill of Rights places expanded responsibilities on teachers, school administrators and boards of education to protect students from incidents of bullying, harassment and intimidation; and
