Chapter Bylaws
of the
McVay Chapter
of the
National Honor Society
Adopted: May 23, 2017

ARTICLE I: NAME

The name of this chapter shall be the McVay Chapter of the National Honor Society of West Liberty High School, West Liberty, Iowa.

ARTICLE II: PURPOSE

The purpose of this chapter shall be to create an enthusiasm for scholarship, to stimulate a desire to render service, to promote worthy leadership, and to encourage the development of character in students of West Liberty High School

ARTICLE III: POWERS

Section 1: This chapter operates under the direction of and in full compliance with the National Constitution of NHS. See www.nhs.us/constitutions. In addition, this chapter will maintain active affiliation with the national organization on an annual basis.

Section 2: The chapter adviser is given the authority to supervise the administration of chapter activities, as delegated by the school principal.

Section 3: Final authority on all activities and decisions of the chapter resides with the school principal. [For reference, see Article V, Section 1 of the National Constitution.]

Section 4: Nondiscrimination. Our chapter of NHS maintains policies and practices that are designed to prevent discrimination against any qualified candidate or member on the basis of race, color, religion, ancestry, national origin, gender, and disability. This policy of nondiscrimination applies to all practices, including the chapter administration and the selection, discipline, and dismissal of members.

ARTICLE IV: MEMBERSHIP

Section 1: Membership in this chapter is an honor bestowed upon deserving students by the faculty and shall be based on the criteria of scholarship, service, leadership, and character.

Section 2: Membership in this chapter shall be known as active, honorary, and alumni. Active members become alumni members at graduation. Alumni and honorary members have no voice or vote in chapter affairs.

Section 3: Eligibility:

- a. Candidates eligible for selection to this chapter must be members of the <u>sophomore, junior</u>, or senior class.
- b. To be eligible for selection to membership in this chapter, the candidate must have been enrolled for a period equivalent to one trimester at West Liberty High School.
- c. Candidates eligible for election to the chapter shall have a <u>minimum cumulative grade point</u> <u>average of 3.5 on a 4.0 scale</u>.
- d. Upon meeting the grade level, enrollment, and GPA standards, candidates shall then be considered based on their service, leadership, and character.



ARTICLE V: SELECTION OF MEMBERS

Section 1: The selection of members to this chapter shall be by a majority vote of the faculty council, which consists of five faculty members appointed by the principal. The chapter adviser shall be the sixth, nonvoting, *ex officio* member of the faculty council.

Section 2: The selection of active members shall be held once a year during the second trimester of the school year.

Section 3: Prior to the final selection, the following shall occur:

- a. Students' academic records shall be reviewed to determine scholastic eligibility.
- b. All students who are eligible scholastically (i.e., candidates) shall be notified via their school email and asked to complete and submit the <u>candidate information form</u> for further consideration.
- c. The faculty shall be requested to evaluate candidates determined to be scholastically eligible using the official input form provided by the chapter adviser.
- d. The faculty council shall review the candidate information forms, faculty input, and other relevant information to determine those who fully meet the selection criteria for membership.

Section 3: There will be no hearing or review on the judgment of the faculty council on the selection of individual members. All appeals should be made to the principal.

Section 4: Candidates become members when inducted at a special ceremony.

Section 5. An active member of the National Honor Society who transfers from this school will be given an official letter indicating the status of his/her membership.

Section 6: An active member of the National Honor Society who transfers to this school will be automatically accepted for membership in this chapter. The faculty council shall grant to the transferring member one trimester to attain the membership requirements and, thereafter, this member must maintain those requirements for this chapter in order to retain his/her membership.

ARTICLE VI: OBLIGATIONS OF MEMBERS

Section 1: Annual dues for this chapter shall be \$5.00. Dues will be payable to the chapter within 30 days of induction.

Section 2: Each member of this chapter who is in good standing with regard to the membership standards and member obligations shall be entitled to wear the emblem adopted by the National Honor Society.

Section 3: Any member who withdraws, resigns, or is dismissed from the chapter shall return the emblem to the chapter.

Section 4: Chapter members who are seniors in good standing shall be granted the **privilege** of wearing the honor cords at graduation.

Section 5: Members are expected to participate in any chapter service projects.

Section 6: Members are expected to model high standards of good character by demonstrating integrity through their trustworthiness, respect, responsibility, fairness, caring, and citizenship.

Section 7: Members are expected to encourage high scholarship by challenging themselves through participation in Advanced Placement courses, as they are able, and by always seeking more knowledge rather than choosing the easy path.

ARTICLE VII: OFFICERS

Section 1: The officers of the chapter shall be president, vice president, secretary, treasurer, and historian.

Section 2: Student officers shall be elected at the last meeting of each school year. All returning members in good standing with the chapter are eligible to run for a position as an officer. Any active member can nominate an eligible member as a candidate for office.

Section 3. Voting shall be by secret ballot. A majority vote shall be necessary to elect any officer of this chapter. If the first vote does not yield a majority, a second vote shall be taken of the two candidates receiving the highest number of votes.

Section 4: It shall be the duty of the president to preside at the meetings of the chapter, and serve as the official representative of the chapter at school and community functions.

Section 5: The vice president shall preside in the absence of the president and shall also keep a record of members' contributions to leadership and service.

Section 6: The secretary shall keep the minutes and attendance records for meetings and be responsible for all official correspondence.

Section 7: The treasurer shall keep the record of business expenses, dues, and all other financial transactions of the chapter.

Section 8: The historian shall maintain and add to the historical record so that it is available for others to see the history of the local chapter. This will be on display at the annual induction ceremony and reception.

Section 9: Officers and the faculty adviser(s) shall collectively be known as the chapter's executive committee. The executive committee shall establish annual goals for the chapter and have general charge of the meetings and the business of the chapter, but any action by the executive committee is subject to the review of the chapter members.

ARTICLE VIII: MEETINGS

Section 1: Regular meetings of this chapter shall be monthly. The president with approval of the adviser can call special meetings.

Section 2: This chapter shall conduct its meetings according to Robert's Rules of Order.

Section 3: Members are expected to attend all chapter meetings. If a member must miss, the adviser should be notified prior to the meeting.

Section 4: If 80% attendance is not maintained, excluding excused absences, the member will be notified and may be put on probation with review of continued membership by the faculty council.

ARTICLE IX: ACTIVITIES

Section 1: The chapter shall determine one or more service projects for each year.

Section 2: All members shall regularly participate in these projects.

Section 3: These projects shall have the following characteristics: fulfill a need within the school or community; have the support of the administration and the faculty; be appropriate and educationally defensible; and be well planned, organized, and executed.

Section 4: Each member shall have the responsibility for choosing and participating in an individual service project, which reflects his or her particular talents and interests, and as approved by the chapter adviser. This is in addition to any of the chapter projects to which all members contribute.

Section 5: The chapter shall publicize and promote its projects in a positive manner.

Section 6: The student who serves:

- a. Is willing to uphold scholarship and maintain a loyal school attitude.
- b. Participates in some outside activity: Girl/boy scouts; church groups; volunteer services for the aged, poor or disadvantaged: or has family duties.
- c. Volunteers dependable and well-organized assistance, is gladly available and is willing to sacrifice to offer assistance.
- d. Works well with others and is willing to take on difficult or inconspicuous responsibilities.
- e. Cheerfully and enthusiastically renders any requested service to the school.
- f. Is willing to represent the class or school in inter-class or inter-scholastic competitions.
- g. Does committee and staff work without complaining.
- h. Shows courtesy by assisting visitors, teachers and students.

Section 7: The member who exercises leadership:

- a. Is resourceful in proposing problems, applying principles and making suggestions.
- b. Demonstrates leadership in promoting school activities.
- c. Exercises influence on peers in upholding school ideals.
- d. Contributes ideas that improve the civic life of the school.
- e. Is able to delegate responsibility.
- f. Exemplifies positive attitudes.
- g. Inspires positive behavior in others.
- h. Demonstrates academic initiative.
- i. Successfully holds school offices or positions of responsibility, conducting business efficiently without prodding, demonstrate reliability, and dependability.
- j. Is thoroughly dependable in any responsibility accepted.

Section 8: The student of character:

- a. Takes criticism willingly and accepts recommendations graciously.
- b. Consistently exemplifies desirable qualities of behavior. (Cheerfulness, friendliness, poise and stability)
- c. Upholds principles of morality and ethics.
- d. Cooperates by complying with school regulations concerning property, programs, office, halls, etc.
- e. Demonstrates the highest standards of reliability and honesty.
- f. Shows courtesy, respect and concern for others.
- g. Observes instruction and rules, punctuality and faithfulness both inside and outside the classroom.
- h. Has power of concentration and sustained attention as shown by perseverance and application to studies.
- i. Manifests truthfulness in acknowledging obedience to rules, avoiding cheating in written work and showing unwillingness to profit from the mistakes of others.
- j. Actively helps to rid the school of bad influences or environment.

ARTICLE X: DISCIPLINE and DISMISSAL of MEMBERS

Section 1: Any member who falls below the standards of scholarship, service, leadership, or character may be considered for discipline or dismissal from the McVay chapter of the National Honor Society. A member of the National Honor Society is expected to maintain his/her academic standing and take an active role in service and leadership to his/her school and community.

Section 2: If a member's cumulative grade point average falls below the standard in effect when he/she was selected of a minimum of 3.5 on a 4.0 scale, he /she will be given a written warning and a reasonable time period for improvement. If the cumulative grade point average remains below standard at the end of the warning period the student will be subject to further disciplinary action by the faculty council that includes consideration of dismissal from the chapter.

Section 3: Violations of the law or school regulations can result in immediate consideration of the dismissal of a member (see Section 5 below). These violations include, but are not limited to DWI, stealing, destruction of property, cheating, truancy, or possession, selling, or being under the influence of drugs or alcohol at school or school-related activities or in the community.

Section 4: Offenders of the school conduct code (such as use of profanity, failure to comply, unexcused absences, excessive tardiness, etc.) will receive written warning notification. In such cases either party (faculty council or student/parent) may request a conference. If the member is involved in another violation of the school conduct code, the member may be considered for dismissal.

Section 5: Chapter officers, as representatives of the chapter, can be removed from their positions as a consequence of disciplinary action taken by the faculty council.

Section 6: All members will be subject to annual review by faculty as to how their leadership, character, service, and scholarship are observed both in and out of the classroom. Upon results of this review, with a preponderance of evidence, members will receive written warning notification/consequences as in section 4.

Section 7: In all cases of pending dismissal:

- a. The member will receive **written notification** from the adviser/faculty council indicating the reason for consideration of dismissal.
- b. The member has the **right** to respond to the charge(s) against him/her at a **hearing** before the faculty council prior to any vote on dismissal (in accordance with due process identified in Article X of the National Constitution). The member has the opportunity to present his/her defense either in person or via a written statement presented in lieu of the face-to-face hearing. Following the hearing, the faculty council will then vote on whether to dismiss. A majority vote of the faculty council is needed to dismiss any member.
- c. The results of the faculty council vote will be presented to the principal for review, and then stated in a letter sent to the student and parents. Dismissed members must surrender any membership emblems to the adviser.
- d. The faculty council's decision may be appealed to the building principal and afterwards according to provisions of the school district discipline policies.
- e. A member who is dismissed or resigns may never again be considered for membership in the National Honor Society.

Section 8: In lieu of dismissal, the faculty council may impose disciplinary sanctions upon a member as deemed appropriate.

ÄRTICLE XI: RATIFICATION, APPROVAL, and REVIEW.

Section 1: These bylaws will be **approved** upon receiving a two-thirds affirmative vote of all active members of the chapter, a majority affirmative vote of the faculty council, and approval by the administration.

Section 2: These bylaws shall be reviewed and if necessary, revised within five years from the date of approval noted on this document.

ARTICLE XII: AMENDMENTS

These bylaws may be amended by a 2/3 vote of the chapter, provided notice of the proposed amendment has been given to members at least <u>one week</u> prior to the vote. The exceptions are Articles V and X, which are developed by the faculty council with the approval of the principal (selection and discipline).
