6. Delegations

- Associated Student Body (ASB)
 - o Delegation report by Tiffany Angel, ASB Secretary
 - Shared with the board the conversation about the issues in the bathroom and reported she asked if students could have a meeting to deter the behavior. They all met as they were concerned that HS bathroom privileges were going to be taken away. Mr. Bradford talked to teachers so Tiffany and group could address the students.
 - School spirit-some apathy and lack of communication can be a problem.
 Artists are coming to school and they are working with them to see how the building can "pop" out. Possibly decorating lockers to show self-expression and school spirit. Next steps are to figure out a plan and then move forward.
 - ASB funding the senior trip and will give \$2000 to the class of 2022 because everyone should be able to experience event.
 - Prom planning is underway. ASB wants it to be more successful than Homecoming (which was a disappointment because of lack of participation and decorations that were not as expected). The date is May 14th. Kevin asking if we can lend a hand financially? Mr. Bradford clarifies we can't mix public funds for ASB per state law, but ASB can get donations. Kevin suggests next Lions club breakfast will be for ASB.
 - Class 2022 also would like to do an end of the school year event at the school. This is still under discussion and details will be shared once it's further along. Kevin encouraged Tiffany and her leadership skills. Tiffany thanked Ms. DeRuwe for volunteering her time in the classroom
- Prescott Education Association (PEA) Per Jennifer Hammer, PEA President:
 - We agreed to a 180-day calendar for next year
 - Calendar committee meets Wednesday 2/9 to start planning the 22-23 calendar and a lot of input has already been received.
 - PEA has no objection to calendar adjustment the last week in March to shift conferences to Wednesday and Thursday and have half day (for students) on Friday,
 4/1 which is also end of 3rd quarter AND makeup one of the snow days.

- Delegates, Visitors, and Guests
 - Class of 2022
 - VP Michell Morales, Sentinel Ivan Martinez, Manny Sanchez, told the School Board about the Class of 2022 Senior Trip to Coeur d'Alene, Idaho, May 30-June 2nd where they have rented a large private home. The plan to stay 3 nights and 4 days. Planned activities include Silverwood and a Cour d'Alene Lake cruise). Students also planning one night out to dinner. Girls and the boys will each take a cooking night. The goal is to take the last couple days they are together to have fun. It's a lake house and there is a dock on the water, board games in the house, Hot tub, fire pit. Board is very supportive and happy they are all going to be together. With the help of ASB the Class of 2022 has only a few more bake sales then they will have all the money. 10 students are going with a few chaperones (Ada Gonzalez and Ryan Anderson).
 - Graduation Date Change Request- Class of 2022 would like to move it to Saturday June 4 at 1pm because of many of the families work schedule on Friday, June 3rd. Families have Saturday off and can go to graduation then go home and enjoy the graduations celebrations. Kevin says that makes great sense for the families then asked how would it affect staff? Mr. Bradford would like to see all staff to attend Graduation, although they haven't always showed up. He doesn't have a problem having it on a Saturday and Kevin feels it makes more sense. Preston, Jacob and Sue agree. Graduation is moved to June 4th, Saturday at 1pm at Prescott Schools.

7. Reports

- Legislative Justin Bradford
 - Masks-Richland and Kettle falls School Board voted to make masks optional. Richland was surprised by the Board vote because it was an illegal move. Superintendent closed school until they could figure out what they would do next. The Governor announced today mask mandates end on March 21. Mr. Bradford will send an all staff email tomorrow that says when it will end and emphasize that until then we will be wearing masks in the building and buses.
 - Other Legislative issues-COLA increases possibly to deal with inflation
 - Dual credit programs-College in the High school (EWU English courses taught in Mr. Anderson's class are dual credit)
 - Preston asked about FTEs with College in the High School. Mr. Bradford says one of the reasons he likes College in High School is it keeps FTEs with the school district (as opposed to Running Start). Kids take it as it reduces the cost of college because the courses are no charge when taken while enrolled in High School.
 - Sue-with R. Anderson dropping down to Jr. High, we need to be sure his
 replacement is qualified to teach College in the High school. We want to be
 sure to keep it.

• No budget cuts in the future. The state is doing really well economically.

• Athletic Director – Jeff Foertsch

- We are currently trying to hire for esports and Track. The seasons will start in March. JH girls' basketball is currently going on. The season will end at the end of February.
- We will be using PLC time this spring to have a coach's meeting to continue to work on how to get more students to participate in the future. I am also planning a survey of parents and students later this spring to hear their voices about next year.
