# Indian Policies and Procedures Dufur School District 2023 Application Year Application Number: 472004

It is the intent of the Dufur School District that all Indian children of school age have equal access to all programs, services and activities offered within the school district. To this end, the Dufur School District will consult with local Tribal officials and parents of Indian children in the planning and development of Indian Policies and Procedures (IPPs), general education programs, and activities. These policies and procedures will be reviewed annually and revisions will be made within 90 days of the determination that requirements are not being adequately met.

#### **Attestations**

The Dufur School Districts attests that it has established Indian Policies and Procedures (IPPs) as required in section 7004 of the Impact Aid law for any children claimed who reside on eligible Indian lands. The IPPs have been disseminated to the Warm Springs and Yakama tribes and parents of children residing on eligible Indian lands. A copy of the current policies and procedures is attached to the FY 2023 Impact Aid application.

The Dufur School District attests that it has provided a copy of written responses to comments, concerns and recommendations received from Tribal leaders and parents of Indian responses to Tribal leaders and parents of Indian children prior to the submission of their FY 2023 Impact Aid application.

#### **Indian Policies and Procedures**

The following Indian policies and procedures become effective upon school board approval.

Policy 1: Dufur School District will disseminate relevant applications, evaluations, program plans and information related to the district's education program and activities with sufficient advance notice to allow tribes and parents of Indian children the opportunity to review and make recommendations. [34CFR222.94(a)(a)]

#### Procedure 1:

The completed applications, evaluations, and program planning will be disseminated to parents of Indian children and Tribal officials via mail or the District's website and information will be prepared and disseminated via mail 10 days in advance of public hearings held in January and April to afford all interested parties the opportunity to review the documents with sufficient time to provide thoughtful input at the public meetings. These hearings will be publicly advertised by the school website to allow all

interested parties to attend. In addition, representatives from the District will schedule a meeting with Tribal leaders and parents of Indian students to annually share the proposed IPPs and to seek input.

Parents of Indian children, Tribal officials and the public will be given notice of meetings related to equal participation or the content of the educational program by including information about meeting times and locations on the school website or mail.

Parents of Indian children, Tribal officials and any other interested persons can review assessment data to help develop or modify educational programs and services allowing for the participation of Indian students on an equal basis in the district.

Policy 2: The Dufur School District will provide an opportunity for the Warm Springs and YakamaTribes and parents of Indian children to provide their views on the District's educational program and activities, including recommendations about the needs of their children and on how the District may help those children realize the benefits of the educational programs and activities. [24CFR222.94(a)(2)]

- (i) Notify tribes and the parents of Indian children of the opportunity to submit comments and recommendations, considering the tribe's preference for method of communication and
- (ii) Modify the method of and time for soliciting Indian views, if necessary, to ensure the maximum participation of tribes and parents of Indian children.

#### Procedure 2:

The Dufur School District surveys the parents of Indian children and Tribal officials via mail or email in the Spring to provide an opportunity for the Warm Springs and Yakama Tribes and parents of Indian children to provide their views on the District's educational program and activities, including recommendations on the needs of their children and on how the District may help those children realize the benefits of the educational programs and activities.

The Dufur School District Board of Directors meets on a regular basis for the purpose of addressing comments and concerns of parents of Indian children regarding the District's educational programs and activities. All meetings are open to the public allowing for Tribal officials as well as parents of Indian children the opportunity to submit comments and recommendations for consideration.

The Dufur School District provides the opportunity for consultation with the Tribes prior to the adoption of these board policies. The Warm Springs and Yakama Tribes prefer all communication with the Tribe and parents of Indian children be disseminated via mail or email.

The District will, to the extent possible, take the Tribes' preferred method of communication into consideration for all correspondence with the Tribes and the parents of Indian children for consultation on these IPPs and the educational program and activities.

At each of the regular school board meetings, a section of time is set aside for communications from the public. This is a time to offer comments and suggestions regarding programming for Indian students. In addition, two public hearings are scheduled in January and April which are specifically devoted to addressing questions regarding federal programs. Suggestions from Tribal officials as well as parents of Indian children will be considered.

Policy 3: The Dufur School District will annually assess the extent to which Indian children participate on an equal basis with non-Indian children in the District's education program and activities. [24CFR222.94(a)(3)]

- (i) Share relevant information related to Indian children's participation in the LEA's education program and activities with tribes and parents of Indian children; and
- (ii) Allow tribes and parents of Indian children the opportunity and time to review and comment on whether Indian children participate on an equal basis with non-Indian children.

## **Procedure 3:**

Each Summer the Dufur School District shall evaluate from District records the ratio of Indian children compared to other children participating in academic programs, co-curricular programs, attendance and graduation for the preceding year. This data will be posted on the District Website by September 1.

After October 1, administrators, staff members, Indian parents, and Tribal officials will hold a meeting to evaluate the extent of Indian children's participation in the educational programs for the preceding year. At such meetings, attendees will analyze and evaluate the School District data to determine the extent of equality of Indian children's participation with other children.

As needed the District will establish a task force or an ad hoc committee of administrators, Indian parents, Tribal officials, and staff members to assist in the development of recommendations to modify educational programs in order to ensure the equal participation of Indian children. Such a committee shall make recommendations to the District as to any recommended modifications for consideration.

Parents of Indian children or Tribal officials may comment on the results at regularly scheduled School Board meetings or directly to the School District by email or in writing.

Policy 4: The Dufur School District will modify the IPPs if necessary, based upon the results of any assessment or input described in this document. [34CRF222.94(a)(4)

## Procedure 4:

The Dufur School District Board of Directors has scheduled meetings in January to discuss the content of the IPPs and in April to discuss educational programs and activities. Parents of Indian children and Tribal officials are notified via mail or email regarding these meetings and their opportunity to submit comments. In addition, the parents of Indian children and Tribal officials may make recommendations to the IPPs or the educational program at any regularly scheduled School Board meeting, or in direct communication with the school district.

The District presents a draft version of the IPPs to the Board of Directors at their monthly meeting prior to the January 2023 school board meeting for consultation and collaboration on the content.

The District will evaluate all recommendations for changes to these IPPs.

The District will decide on all recommended revisions to these IPPs.

Any changes approved by the Dufur School Board of Directors will become effective immediately upon adoption.

The Dufur School District will post the revised IPPs on the District website within 30 days of adoption by the Dufur School Board of Directors and the District will send a revised copy of the IPPs to the Impact Aid Program at the U.S. Department of Education within 30 days of adoption by the Dufur School Board of Directors.

Policy 5: The Dufur school District will respond at least annually in writing to comments and recommendations made by the Warm Springs and Yakama Tribes or parents of Indian children, and disseminate the responses to the Tribe and parents of Indian children prior to the submission of the IPPs by the District. [34CRF222.94(a)(5)]

# Procedure 5:

The Dufur School District will respond at least annually in writing to the comments, questions and concerns received throughout the IPP consultation process. In the event that the school district receives multiple comments on the same topic area, the Dufur School District will summarize these comments and respond to them as a group.

The Dufur School District will respond to comments, quests and concerns received through the consultation process in writing no later than September 30 of each year.

The summary of the responses to the comments, concerns and recommendations through the consultation process will be available to the Tribes and parents of Indian children on the District website.

Policy 6: The Dufur School District will provide a copy of the IPPs annually to the affected Tribes. [34CRF222.94(a)(6)

# Procedure 6:

The Dufur School District mails a copy of the current Indian Policies and Procedures to the local Tribes and residents of the community each December.
