

Bid Specifications - Lawn Maintenance - Dryden Community Schools

The contractor agrees to provide all of the labor required to perform the following: Grass cutting and trimming at Dryden Community Schools;
Dryden High School at 3866 Rochester Road
Dryden Elementary at 3835 Mill Street
Cardinal Field located at Atwell Street and North Street

SPECIFICATIONS OF SERVICES:

All district sites shall be mowed weekly to maintain a neat appearance unless the contractor is notified in advance that the lawn does not need to be mowed that week. If notified in advance, contractor will skip one week of mowing. Sites shall not be mowed and trimmed more frequently unless requested by owner.

Mowing shall occur approximately one time per week at each site and in no case shall more than 10 calendar days pass between mowing, unless notified in advance, as per paragraph one. Each cutting shall be completed the same day or on consecutive days. October and November mows will be as needed. We do not need weekly mowing then.

Trimming shall be done simultaneously with the mowing operation and done in all areas that are inaccessible to mowing equipment including fence lines, back stops, play areas, playground equipment, under fixed bleachers, next to buildings where established plantings are not present and around all other obstacles to provide a neat and even appearance to the entire site.

All non-turf areas such as sidewalks, entrances, planters, shall be free of clippings and cutting debris via means of blowers, sweepers or other equipment.

Round up or weed control is to be used and applied by a licensed contractor on fenced areas. This is at the contractor's expense, and must be approved by school authorities before applied.

SAFETY AND PROTECTION OF SITE:

A certificate of Liability Insurance, the amount to be no less than \$1,000,000, must be presented naming the District as additional insured. A certificate of Worker's Disability Compensation Insurance must be provided.

COST

Lawn mowing cost is by the cut. Dryden Community Schools will pay invoices on a monthly basis.
