The individual appointed will serve until May 2021 when an election will be held to fill the Place 1 term. The individual appointed by the Board has the choice whether or not to file for a place on the May 2021 ballot. *NOTE: The Place 1 term is set to expire in May 2021, and voters at that time will elect a candidate to fill the seat for the usual three-year term.*

To be eligible to be appointed to the office of school board member, a person must:

1. Be a United States citizen.
2. Be 18 years of age or older on the first day of the term to be filled at the election or on the date of appointment, as applicable.
3. Have not been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated or partially mentally incapacitated without the right to vote.
4. Have not been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities.
5. Have resided continuously in the state for twelve (12) months and in the territory from which the office is elected for six (6) months immediately preceding the date the appointment is made.
6. Be registered to vote in the territory from which the office is elected on the date described at item 5, above.
