(3.a) Robert Eckert, Acting Superintendent

- Enrollment is doing good, as expected.
- The September ending fund balances for all funds was presented.
- Our two business consultants have closed the 2016-2017 Fiscal Year End Report last week and it's been submitted
 and accepted by the ESD; it is now in process to be submitted to the state. They have now begun to work on our
 chart of accounts/coding system.
- We had overspent the grants budget but we are working on fixing the problem to avoid this from happening in the future.
- I created an Emergency Closure/Delay Phone Tree chart that we will be following in the case we need to delay or close school. Donna Ziegler (Transportation Director) and I will communicate in the morning and when I make a decision, I will contact my group of staff, then they will contact their group until everyone on the chart has been contacted. If bus drivers choose not to drive, after taking all precautions into consideration, they will need to take an unpaid day off.
- Vance Frost will present at the December meeting regarding the Junior High and High School CTE programs and Sentinel Tech.
- Potential levy added to the ballot for February 2018; We'll need to approve the resolution at the December board meeting.
- Board and I will be attending the WSSDA conference this weekend.

(3.b) Missy Stevenson, Curriculum & Instruction

We had about 30 staff (teachers and administrators) attend AVID at Sand Diego this last Summer. AVID is a K-12 grade system. I am the District Director for AVID so I attend different trainings and bring the feedback to our staff. AVID structures are doing great in our schools. Currently, Morris Schott Elementary is focusing on the organizational piece and

teachers have started to see a difference (students exchanging information/converse more).

We will be recruiting volunteer tutors from the community to help tutor our students after school; other schools do the same and they have community members from the police and fire department volunteering.

AVID is basically opening the door and language of "College" to parents to be able to get all the information they need to support their children.

We sent a group of teachers to Teachers Development Group (TDG) training this last June and they are now using these math strategies in their classrooms; there is multiple math levels. We also had program coaches come train our teachers this last Summer. Teachers are seeing the difference in students. TDG's strategies build more engagement and discussion between students. We'll also be doing walkthroughs in the buildings one hour per week.
