## (3.b) John Ellsworth, High School - Out of State Travel Request

John Ellsworth Robotics Advisor along with 5 team members; Audiel Mendez, Victor Quintaro, Abraham Mendoza, Salvador Godoy. They wanted to thank the Board for their support of Robotics and to request out of state travel to Worlds VEX Robits in Kentucky in April. So far one student has raised about \$4,000.00 for the team to attend. This is the first time for Wahluke Robotics going to Worlds. Board members approved the teams to attend.

## (3.c) Carrie Harris, School Nurse - Covid 19 Virus update

Dan Fox filled in for Carrie Harris.

Nurses are in schools giving presentations on what to do and not to do in regards to the Covid 19 Virus; correct way to wash hands, cover cough etc. Emphasizing on washing hands before meals, and after recess.Transportation is sanitizing the buses two times a day. Maintenance Dept. is sanitizing touch points two times a day as well. Cleaning only once a day and on Friday with no school they will do a deeper cleaning. Technology Department is providing rags and product to clean devices and has information on how to clean them. The Health Department has asked the school district to stop the use of group pencils, etc as that is a big source of germs. Large groups and events are postponed. Out of district field trips to western Washington are case by case. Fever protocol is 100.4 or higher and students need to stay home for 24 hours or 72 hours if respiratory symptoms exist. A letter was sent home today to add if you have a cough and congestion to stay home.

Anna Marie Dufault and Alex shadowed the Yakima School Dist. and found out that the SSO is still needed. The City of Mattawa and Wahluke School District are working well together.
