Dear Parent/Guardian:

Your home address is not eligible for transportation due to its proximity to school under Board Policy 8600. *Board Policy 8600 Pupil Transportation* may be viewed on the district website, [www.hvrsd.org](http://www.hvrsd.org) by using the *Board* and then *Policies* links.

As we have done in the past, the Board is prepared to assist parents who are interested in parent-paid transportation for students by arranging for subscription bus service. Essentially, this would mean paying for a seat for your child for the year. The cost for this option would be \$500 for the year.

If you are interested in this service, please return the enclosed application form for Elementary Subscription Busing with payment (see payment instructions at the bottom of the application form) to the attention of Ms. Heather Van Mater before **August 6, 2020**. **This information is needed to solicit quotes for transportation services for the 2020-2021 school year. Please note that the Transportation Department may not be able to guarantee that a seat will be available for your child if a request is received after this deadline.**

In an effort to reduce capacity on the buses due to protocols established to fight Covid-19, we are asking families to consider not using the service this school year unless necessary.
