Reports

1. Superintendent’s Report:
 - a) Mr. Fry acknowledged the great work of Dan See and Kevin Gerking who are filling in while Mike Nygaard and Brad Zaro were out on an emergency basis.
 - b) Mr. Fry shared with the board discussions he has had regarding growth in new construction beginning in CP. A 24-unit complex is under way at 8th/College Av., 180 units are to begin in October behind Home Depot, 35 homes at Homestead, 70 units in The Villages, and the nearly 400 homes/300 apartments/300 individual workforce spaces across from CPHS.
2. Principals’ Reports
 - a) Davis Elementary: Principal Ferraro, shared they will have their 1st all school assembly since the pandemic where they will “pie” the administrators for a successful fundraiser. Davis Reads was a huge success with staff recording reading a book to share with students at home in English and Spanish. Davis is preparing students for the ever-important assessment season. Family Night, Thursday March 30th and the Kindergarten Carnival April 13th for the 2024 incoming kindergarten students.
 - b) Sager Middle School: Principal Bell welcomed incoming Principal, Chris Plucker. She shared about the honor roll ski trip with more than 150 students attending. Destination Imagination under the leadership of Ted Knauft taking 4th in State with four teams competing and CP High School and Sager Middle School who shared a guest speaker “Cool Speak” with a focus of progress over perfection.
 - c) CP High School: Mr. Aguilar shared about the success of Adult Night School. On average 15-20 parents from the Hispanic community attending Monday - Thursday. Administrators and counselors are leading targeted intervention groups with identified students in study skills, emotional regulation, and growth. In April & May CPHS will focus their character development in CP Strong on a “Grow It Challenge”. Fan attendance at sporting events has increased this year especially in soccer and baseball.

3. Kari Weed and Nick Walsh reported on plans for summer school. There will be programs at each school. PreK-8 with academic and STEM focus, 8th grade transition to high school, CPHS credit recovery. CPPS will partner with YMCA to provide afternoon programs for students involved in summer school. CPPS programs will run Monday-Thursday in the morning only for 5 weeks.
