**20-F-106 APPROVAL – PRITCHARD INDUSTRIES CONTRACT**

**(AMENDED)**

WHEREAS, the Englewood Public School District has advertised for Custodial, Grounds, Snow Removal and Management Services Request for Proposals and received three proposals; now

THEREFORE, BE IT RESOLVED, upon the recommendation of the Superintendent of Schools, the Englewood Board of Education awards a contract to Pritchard Industries for **Custodial, Grounds, Snow Removal and Management Services** in the amount not to exceed **\$1,966,351.88** for the 2020-2021 school year. This represents year one (2020-2021) with an option to renew for five years.

**20-F-107 APPROVAL – GRADUATION EXPENDITURES**

WHEREAS, due to Covid 19 all New Jersey public schools have been mandated to close and cancel traditional graduation ceremonies per executive order by Governor Murphy; and

WHEREAS, due to Covid 19 mandates expenditures for the District's traditional graduation ceremony will not occur and funds are available

THEREFORE BE IT RESOLVED, upon the recommendation of the Superintendent of Schools, the Englewood Board of Education approves the following Class of 2020 graduation expenses to be paid as result of funds being available due to cancellation of a traditional graduation ceremony.
