Dear Parents:

While the Tonawanda City School District does **NOT** have a confirmed case of COVID-19, caused by the novel Coronavirus (SARS-CoV-2) in our schools, we are aware of concerns in the community about the spread of this relatively new virus.

Our district is closely monitoring this fluid situation and following guidance from the US Centers for Disease Control (CDC), and the New York State Department of Health (NYSDOH), Erie County Department of Health and the New York State Education Department. I have been in contact with Gale R. Burstein, MD, MPH, FAAP, Erie County Commissioner of Health regarding this concern and the actions being taken by the district.

Based on recent reports, two cases of COVID-19 were identified in or near New York City but is not actively circulating in New York State at this time. If the district becomes aware that a student or staff member is diagnosed with COVID-19, it will immediately notify staff and parents/guardians. If a student or staff member shows respiratory symptoms, we will follow our current practices for handling respiratory illnesses, subject to any additional guidance forthcoming.

The current guidance from the CDC states the most important thing for schools to do at this time is plan and prepare. Our district has infectious disease protocols in place and has been taking steps, such as cleaning and disinfecting throughout the schools as well as working with our transportation service to minimize the spread of viruses and a variety of other illnesses. There are a number of steps that students, staff and community members can take to minimize the spread of all respiratory illnesses, including COVID-19, according to the state Department of Health:

- Wash your hands often with soap and water for at least 20 seconds. If soap and water are not available, use an alcohol-based hand sanitizer. Heavily soiled hands should be washed.
- Avoid touching your eyes, nose and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Stay home when you are sick.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces

If you or a family member begin showing symptoms of a respiratory disease and suspect it may be COVID-19, contact your healthcare provider. Before going to your healthcare provider's office, inform them that a case of COVID-19 is suspected, and follow their advice.

Local health departments will contact schools if a suspected or known COVID-19 case emerges. The district is prepared to work with any affected families.


