OUT-OF-DISTRICT CONTRACT Permission to attend Bluestem, USD 205 Public Schools

"All non-district students approved for attendance shall be required to maintain good scholastic standing, good citizenship and good moral character. Any non-resident student who fails to maintain good scholastic standing, good citizenship and/or good moral character shall be subject to having the privilege of attendance revoked."

Guidelines for Out-of-District Attendance:

- Students must be in good standing with the district's behavioral expectations.
- Students must be in good standing with the district's attendance policy.
- Students must be in good standing with the district's academic expectations.
- Students shall not act in a way that is disruptive or detrimental to in-district students.
- Other determining factors may be outlined at administrative discretion.

Any student wishing to participate in extracurricular activities must be in good standing with the KSHSAA and eligible to participate based on the eligibility requirements set forth by USD 205.

USD 205 has the right to terminate this contract at any time the out-of-district student fails to meet these guidelines.

Prior to granting attendance privileges, the building principal will review the student's past history. A recommendation for attendance will be granted based on factors including, attendance, grades, behavior and other factors deemed pertinent as outlined by the building principal. Completion of this form does not grant attendance to Bluestem USD 205. All out-of-district students and applications will be reviewed annually and acted upon at the discretion of the building principal. In the case the applying student has been subject to suspension or expulsion at their previous district, the application will be forwarded to the Superintendent of Schools and Board of Education for a determination of acceptance.

I also grant permission to USD 205 and its designated officials to request attendance, behavior and other student records from the applying student's current and previous school district.
