Guidelines for Addressing Coronavirus Outbreak

I. Purpose/Background

The National Center for Disease Control ("CDC") has officially issued a warning regarding an outbreak of the coronavirus that has been detected in the United States. The following links provide helpful information:

Since the impact of a potential outbreak in schools presents several unique challenges that school districts must be prepared to deal with, we have put together these Guidelines.

State officials have advised that school districts should engage in preparedness planning, and submit plans for school closures to the executive county superintendent for approval. Below are the factors that should be considered and incorporated into a preparedness plan.

II. Key Actions

- School districts should be engaged in contingency planning for a potential outbreak of the Novel Coronavirus (COVID-19).
- Development of response plans and establishment of protocols for communication to the public should the situation escalate.
- School Districts must review and update emergency operation plans. The Plan should emphasize common-sense preventative actions for students and staff, like staying home when sick, covering coughs and sneezes properly, cleaning surfaces with disinfectant, and frequent hand washing. Attendance policies should be relaxed to the extent possible, to allow staff and students to stay home when sick, including ceasing any application of policies that discourage the use of sick time, or reward perfect attendance. Also, a Plan should be in place to keep ill students and staff separate from well students and staff until they are able to be sent home.

- School Districts should develop a Plan for separating students who exhibit coughs, fever, or difficulty breathing from other students until they can be sent home. The Plan should also include the immediate removal of staff members who exhibit symptoms.
- Students or staff who have travelled should be required to provide information regarding their mode of travel and their destination (including any layovers). Consideration should be given to imposing a 14 day quarantine even if they have not traveled to countries listed by the CDC.

III. Board Meetings

The Open Public Meetings Act ("OPMA") applies to gatherings of a quorum. The Open Public Meetings Act does not prohibit the use of virtual or telephone communication of a quorum of school board members, so long as the public is provided with advance notice and an opportunity to witness such communication. In the event of a closure, Boards would have to schedule a public meeting wherein the members are in attendance from remote locations, and the public is able to view and participate in the proceedings via a video screen. Alternatively, the Board may conduct a meeting via conference call where members of the public will have access to the conference call information so that they may listen to and participate in the meeting at the appropriate time. So long as that guidance is followed, the Board would be in compliance with the notice and right to attend provisions of OPMA. A sample Board of Education By-Law and Notice of Public Meeting is attached.

The Board may also consider adopting a Resolution, contingent upon the closing of schools, to authorize the Superintendent and Business Administrator to conduct the normal and routine business of the District subject to ratification of the Board. Most Boards of Education adopt a similar Resolution during the summer months.

In the event that the Board is unable to provide adequate notice or have access the proper technology to conduct a virtual meeting, the Board should cancel the meeting until the threat has been reduced. The notice requirements of the OPMA should be followed in the event that a decision is made to cancel the meeting. If not possible due to the emergent nature of the cancellation i.e. schools order shut down the day of the meeting, best efforts should be made to provide notice and notice of cancellation should be placed on the door of the building where the meeting was to take place. If the Board has notice of closure by directive of the New Jersey Department of Health and a Board meeting is scheduled during that closure, the Board may proactively reschedule the meeting and provide notice in compliance with the "adequate notice" requirements of the OPMA.

IV. School Closings:

a. Alternative Learning/Online Schooling

The possibility of school closures and infected students being sent home for extended periods of time, raises the issue of how to continue educating students. State officials have advised that should the Department of Health direct school closures that the days during which alternative instruction is provided will count toward the 180 day instruction requirement. However, in the interest of ensuring students are not losing significant instruction, the District should review their

access to technology that could enable online schooling. This would include how many devices the school has the ability of sending home with students, and the student's population access to internet at home. This may be accomplished through surveys sent home to parents and guardians of students. The NJDOE has advised that during school closures, schools may stay open for staff (who are not ill) while students stay home, so that teachers may develop and deliver lessons remotely. This applies to the following provisions as well.

Alternative or online learning options must follow a board policy, and plans must be created for each student, especially those students receiving special education services through an IEP. If the District offers online learning during any period of closure, it must still comply with the IDEA and New Jersey's implementing Regulations, meaning that all students must be able to participate in their learning and have access to all educational and related services and support. If the District does not already have online learning plans in place, it is unlikely that they will be able to implement these on short notice in the event of an outbreak of the virus. In which case, Districts should plan for development of hard copy instructional packets that contain at least one hour of instruction to send home to students.

A plan should be developed to share with teaching staff for developing home instruction materials in the event of school closings.

b. Students who are Quarantined

Districts must prepare for how they will educate students who may test positive for coronavirus and be quarantined. Districts should be prepared to offer home instruction to these students or alternative online instruction. Additionally, Districts should be prepared to work on a case by case basis to implement the IEP's of students who receive special education and related services who may be sent home or quarantined.

c. General Education Students

Students who are medically quarantined maintain their rights to a free and appropriate public education. In the event that any individual student is sent home ill or quarantined, and the school district remains open to the remainder of the student population, school districts must be prepared, with protocols in place, to offer those students educational services remotely. This may be done via conversion of face to face lessons to online lessons or hard copy packets, depending on the district and/or the student's access to a device and internet at home.

d. Special Education Students

Provision of education for students with disabilities is an important consideration when engaging in this planning. In the event of individual students being quarantined, school districts remain responsible for the free appropriate public education (FAPE) of its students eligible for special education services with an individualized education program (IEP). Districts will want to plan how they will continue to meet the requirements of the Individuals with Disabilities Education Act (IDEA).

Districts should consider the following during contingency planning:

- If a school closure causes educational services for all students to cease within the school/district, then the school/district is generally not required to provide services to the affected students eligible for special education services during that same period of time. This general standard is especially true in cases where the school district will still provide the required minimum of school days. Home instruction will however be required where individual students are quarantined, but the school remains open to the remainder of the student population.
- Develop a protocol to communicate proactively with parents and guardians regarding their child's IEP services prior to and during a closure, as well as follow-up communication on next steps once the school reopens.
 - o Consider what other agencies and organizations should be included in the communication, including contracted providers and non-public agencies.
 - Review how the closure impacted the delivery of special education and related services to students eligible for special education services.
 - Determine if the delay in services created a need for compensatory services (if the delay in services resulted in a loss of educational benefit based on the degree of skill loss).
 - Determine if the delay in services created or changed the student's need for extended school year (ESY) services based on the length of time of the school outage and the resulting impact of the interruption to the student's services.
- Any decision to provide compensatory services is reviewed by the student's IEP team on a case-by-case basis. If needed, these make-up services should be documented as part of the student's IEP, either with a Prior Written Notice following an IEP meeting and/or through the IEP amendment process.
- Develop a protocol to communicate with school administrators and educators in order to
 prepare staff for any plans to address the needs of students eligible for special education,
 child find activities, evaluations/reevaluations, and IEP implementation.
- IEPs must be implemented immediately upon school starting.
- Any lapsed evaluations, reevaluations, or IEPs should be scheduled for completion upon the start of school.

e. Students who receive meals

Continuity of food services, particularly for school districts' most vulnerable students and families, is another important consideration. Many students rely on school meals to meet their basic nutritional needs. School districts should prepare by working in connection with their food services provider to develop a plan to provide meals to those eligible students. It would be prudent to first prepare a list of all students who are eligible to assess the depth of the challenge to providing food services to students during a school closure. A potential method of ensuring continuation of this service is to offer breakfast and/or lunch for pick up at a central location.

V. Teachers and Staff: Special Considerations:

a. Obligations to Negotiate Changes in Calendar

Unless the District is closed through the written Directive of the New Jersey Department of Health, days the school is closed must be made up so that the 180 instructional day requirement is met. Under New Jersey Law, the decision to modify the school calendar is non-negotiable, as such decisions remain within the managerial prerogative of the Board. However, the impact of that decision may be negotiable. This issue has arisen particularly when due to excessive, unplanned closures, school boards have decided to cancel spring break. In this context, the board has the authority to do so without negotiating, but must bargain over the impact issues such as non-refundable tickets. Simply making individual accommodations is not an appropriate remedy, but rather the Board is required to negotiate the accommodations made for employees who suffered financial hardship as a result of the calendar change. Thus, this should be taken into consideration should schools need to be closed for any prolonged period of time requiring days to be made up at some point during the rest of the school year.

b. Absenteeism and Federal Leave Requirements

The CDC has advised that employers relax attendance policies that may discourage employees from staying home when they are experiencing symptoms of the coronavirus such as fever, cough, runny nose, etc. In an effort to encourage employees to stay home if they are experiencing those symptoms, waiving any requirements for doctor's notes to validate their illness may be in order. Health care provider offices and medical facilities may be experiencing high volumes of patients making it difficult to obtain such documentation. To the extent possible, Districts should plan to temporarily relax any other attendance policy that may discourage the use of sick leave during this time, such as perfect attendance awards

Under the Federal Family Medical Leave Act (FMLA) qualifying employees are eligible for FMLA leave if they have a serious health condition that makes the employee unable to perform the functions of his or her job. An employee who must be absent from work to receive medical treatment for a serious health condition is consider to be unable to perform the essential functions of the position during the absence for treatment. Additionally, individuals qualify for FMLA leave if they need to care for a child, spouse, or parent who has a serious medical condition. Considering that individuals who contract the coronavirus will likely need at least two weeks to recover, Districts should prepare to offer FMLA protection to employees who may become ill, be quarantined, or need to care for a family member who has contracted COVID-19, in accordance with the FMLA procedures already in place. It should be noted however that the FMLA rules regarding notices and documentation have not been lifted. Accordingly, employers must continue to follow their regular and ordinary FMLA process including notice of eligibility and rights and responsibilities, certification, designation notice, and the fitness for duty.

Parliamentary Authority

Roberts' Rules of Order, Newly Revised, shall govern the Camden's Promise Charter School Board of Trustees in its deliberations and acts in all cases consistent with the laws of the State of New Jersey, rules of the State Board of Education, and/or these bylaws.

Quorum

A quorum shall consist of _____ Board members, and no official business shall be conducted in the absence of a quorum.

In the event a quorum is not present at the hour of convening, the meeting may be recessed to a time not later than 9:00 p.m. of the same day. If a quorum is not then present, the members present may adjourn the meeting to a later date within seven days.

Presiding Officer

The President shall preside at all meetings of the Board. In the absence, disability, or disqualification of the President, the Vice President shall act in his/her place; if neither person is present, any member shall be designated by a plurality of those present to preside. The act of any person so designated shall be legal and binding.

Regular Meeting

Regular meetings of the Board shall be public and shall commence not later than 8:00 p.m.

- A. The Board Secretary shall notify each member of the date, place and time of a regular meeting in writing at least twenty-four hours prior to the meeting.
- B. The Board Secretary shall prepare and provide an agenda to each Board member prior to the meeting. Copies of the agenda shall be made available to the attending public.
 - 1. An Action Item Agenda, to the extent known; shall be made available to the public in the office of the Board Secretary three days prior to the regularly scheduled meeting.

- 2. Additional action items, to the extent known, shall be presented prior to the public comments on the agenda portion of the meeting.
- 3. The Board may discuss or act upon matters, raised in open regular meetings by any member of the Board which were not included on the prepared agenda in accordance with the provisions of the "Open Public Meetings Act".
- C. The order of business shall be as follows, unless altered by the President:

BOARD AGENDA FORMAT

Special Meeting

Special meetings of the Board shall be public and shall commence no later than 8:00 p.m.

- A. Special meetings shall be called by the Board Secretary whenever he/she is requested by the President of the Board to do so or whenever there shall be presented to him/her a petition signed by a majority of the whole number of members of the Board. The Superintendent shall be consulted as to the dates of all special meetings and the items to be discussed.
- B. The Board Secretary shall notify each member of the date, time and place of the meeting at least twenty-four hours prior to the special meeting and shall state the purpose thereof. However, special meetings may be called without notice provided to each member of the Board who cannot be reached and has signed a waiver of his/her right to notice thereof.
- C. The order of business shall be as follows unless altered by the Presiding Officer:

Roll call
Reading of Notice of Meeting
Transaction of business of which meeting is called
Adjournment

D. Business other than that for which the meeting was called may be transacted only if all members are present and unanimously agree to hear such matters.

Public Participation

The length of time set aside for public participation shall be limited to no more than thirty minutes or three minutes per person subject to the discretion of the Board President.

The following statement shall be made prior to public participation:

Members of the public are invited to submit comments pertaining to educational matters during the public comment portion of this meeting. The Board, pursuant to the Open

Public Meetings Act, will not publicly discuss personnel matters and may choose not to respond to comments made by members of the public during this portion of the meeting; however, the Board will give all comments appropriate consideration and will refer all initial complaints to the administration for resolution.

Please be aware that all Board employees retain the right of privacy and shall retain all rights against defamation and slander according to the laws of New Jersey. The Board shall not be held liable for comments made by members of the public.

Telephonic Participation

Telephonic communication equipment allows meetings and action even when all members of the Board are not physically present upon prior arrangements being made to afford the public the opportunity to witness the meeting. This provision will allow a Board member to participate in a meeting via speaker phone and/or conference call. A Board member desiring to participate in the discussion and vote on an important issue must authorize the Board to install a speakerphone or other electronic equipment that allows the Board member to hear and be heard. Telephonic participation in closed or executive session shall be limited and only used in emergent situations and upon satisfactory assurances that any discussion shall be and remain confidential.

Conference Call Meeting

The Board may conduct a meeting via conference call where members of the public will have access to the conference call information so that they can listen to and participate in the meeting at the appropriate time. A conference call will only be used in an emergent situation where the Governor of the State of New Jersey has declared a State of Emergency that requires school buildings and offices to be closed. Telephonic participation in closed or executive session shall be limited and only used in emergent situations and upon satisfactory assurances that any discussion shall be and remain confidential.

Virtual Board Meeting

The Board may conduct a meeting utilizing technology that will enable a meeting to occur without the presence of the public utilizing video conferencing or other similar technology. A Virtual Board Meeting will only be used in an emergent situation where the Governor of the State of New Jersey has declared a State of Emergency that requires school buildings and offices to be closed. Telephonic participation in closed or executive session shall be limited and only used in emergent situations and upon satisfactory assurances that any discussion shall be and remain confidential

Voting

A majority vote of all members of the Board present at any meeting shall be necessary for any action of the Board, unless the specific action being voted upon, by law, requires a greater vote. Voting shall be by acclamation. The Board shall vote according to the rules established in Board Policy.

At the discretion of the President, or if any Board member shall so request, or, if the nature of the issue being voted on calls for a resolution (such as appointment of staff, fixing of salaries, expenditures of money); the Board Secretary shall poll the Board on a particular vote. The ayes and nays on any vote shall be recorded in the minutes by name whenever the Board is polled. Proxy voting is not permitted.

Minutes

Minutes shall be kept in sufficient detail to show compliance with the laws and regulations of the State of New Jersey and Board Policy. The Board Secretary shall provide each Board member with a copy of the minutes of the last meeting within four weeks from that meeting.

Adjournment

Upon the concurrence of a majority of Board members present and voting, a recess, an adjournment to executive session or an adjournment to an adjourned meeting of specified date and place may be declared at any point in the order of business. Only matters carried over from the original meeting may be acted upon at an adjourned meeting.

Committee Meeting

The purpose of committee meeting is to conduct investigations, gather data, evaluate information, and to prepare recommendations for the Board.

- A. A meeting may be called at any time by the committee chair; the Board Secretary shall send notice of committee meetings to all members of the Board and to the Superintendent.
- B. Meetings shall be closed except that any member of the Board may attend any committee meeting, so long as a quorum of the Board is not then present, and Board employees, contractors and/or the public may attend upon the invitation of the committee.

Anyone can contract COVID-19, but some groups seem to be impacted more than others.

Cases of the novel coronavirus continue to climb in the United States, and multiple deaths have been reported.

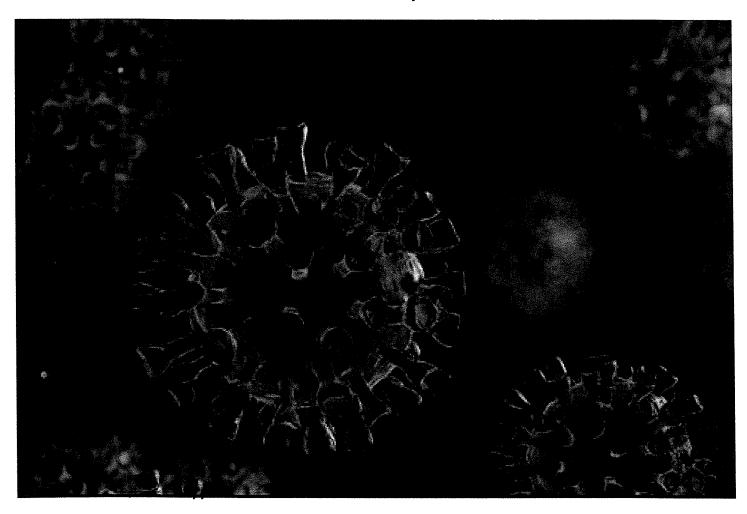
While anyone can contract COVID-19, certain groups seem to be more vulnerable to severe illness and complications.

An infectious disease doctor explains why some groups are considered high-risk, and steps you can take to protect yourself and loved ones.

Cases of the <u>novel coronavirus</u> continue to climb in the United States, with multiple reported deaths, according to the <u>Centers for Disease Control and Prevention</u> (CDC). While *anyone* can contract COVID-19 and experts are "seeing all age groups impacted," some people seem to be more affected by the illness than others, explains infectious disease expert <u>Amesh A. Adalja, M.D.</u>, senior scholar at the Johns Hopkins Center for Health Security.

COVID-19 can cause a spectrum of symptoms, ranging from mild, <u>common cold-like</u> cases, to severe cases that lead to life-threatening complications like <u>pneumonia</u>. There isn't a magical cut-off age for who will and won't experience serious effects from the disease, Dr. Adalja says, but some groups do face a higher risk of complications. Here's what you need to know.

Who is most at risk for novel coronavirus complications?



Most of what is known about the risk factors for COVID-19 is based on what's been reported out of China, 11853 where the novel coronavirus outbreak originated and an overwhelming majority of cases and deaths have occurred. Here are two groups that seem to be especially vulnerable:

Older adults

The majority of deaths from coronavirus have been in the elderly, Dr. Adalja says. "Above age 50 is when you start to see more severe complications," he explains, adding that older patients have a harder time recovering, similar to to the flu. (Common flu complications in high-risk groups include bronchitis and pneumonia, which have also been reported in patients with COVID-19.)

For example, the first novel coronavirus-related death in Placer County, Calif. was confirmed in "an elderly adult with underlying health conditions," <u>local health officials reported</u> in early March. The patient "was likely exposed during international travel from Feb. 11 to 21 on a Princess cruise ship." During the initial outbreak of coronavirus-related deaths in Washington state, a majority of patients were residents of a nursing facility and over the age of 70.

People with underlying health conditions

People with underlying health conditions are at a higher-than-normal risk of developing severe forms of COVID-19, Dr. Adalja says. When your body is already dealing with a separate health condition, it has less energy to put toward fighting an acute infection, he explains. The CDC says these conditions include:

Blood disorders, such as sickle cell disease or taking blood thinners

Chronic kidney disease, as defined by your doctor

Chronic liver disease, as defined by your doctor

Compromised immune system, including undergoing cancer treatment such as chemotherapy or radiation, having received an organ or bone marrow transplant, or taking high doses of corticosteroids or other immunosuppressant medications, and HIV or AIDS

Current or recent pregnancy in the last two weeks

Endocrine disorders, such as diabetes

Metabolic disorders

Heart disease

Lung disease, including asthma

Neurological and neurologic and neurodevelopment conditions

How are younger adults dealing with COVID-19?

People in their 20s, 30s, and 40s seem to have a lower risk of novel coronavirus complications, Dr. Adalja says. "It's very unlikely for young people to have severe cases," but that doesn't mean it can't happen, Dr. Adalja says, especially if you have direct or frequent contact with the disease or an underlying condition. (Li Wenliang, the 34-year-old Chinese doctor who was one of the original whistleblowers on coronavirus died of the virus in early February.)
