Updated lists of required program materials for new students will be posted on each program's web page by August 1, 2020. While we do our best to keep student costs at a minimum, we encourage you to consider applying for the tremendous scholarship opportunity described below, to assist with purchasing necessary supplies.

The Northern Tier Career Center is excited to announce that PS Bank is sponsoring a K-12 Career & Technology Scholarship for students in all NTCC Programs of Study again for the 2020-2021 school year! Last year, NTCC students received almost \$60,000 in program supplies.

- This scholarship will provide recipients with supplies associated with successful participation in the Program of Study and transition into their chosen career fields, including tools, equipment, uniforms, safety gear, and industry certifications. Items vary by program and examples include steel toe boots, mechanic tool sets, cosmetology kits, stethoscopes and scrubs, chef's hats and jackets, and program-specific tools. Students will receive the items, not a monetary award.
- Students must apply using the attached directions in order to be eligible.
- If you plan to apply for the scholarship, you may delay purchasing program materials until you know whether you've received it.

In order to be considered for Round 1 of scholarship distribution and receive your items at the start of the school year, please submit your application per the attached directions no later than July 31st. Applications received after this date will be processed in Round 2 after the school year begins.
