Mr. Wade introduced Dr. Sela, who is retiring in June after 15 years with the district. Dr. Sela stated that over the years the board had shown themselves to be true advocates for the students and thanked them for allowing him to develop his Introduction to Philosophy class. He asked that his legacy be continued and handed out copies of the class syllabus and final essay done by his students this semester.

#### Presentations to the Board

- Mary Gilpatrick updated the board on a grant received by the district from WMHT titled *American Graduate*. She also gave them information on those students currently taking part in the RAPP Program as well as historical data.
- Myles Goss presented his Special Education Annual Report for the 2011-12 school year.

#### SUPERINTENDENT

 Lyn Derway, the Assistant Superintendent of Business, presided over an initial discussion of the 2012 - 2013 budget. Her presentation included a summary of state aid, budget history, expenditures and revenue for the past three years as well as projected expenses and revenues. She outlined some of the challenges the district is facing in developing the budget for the 2012-2013 school year including state and federal mandates as well as the rising cost of health insurance, fuel and retirement contributions.

#### **Public Comment**

- Sarah Atkinson asked a question regarding the salary projections used in the budget presentation.
- Judy Wienman asked what could be done to maintain a level of excellence given the budget constraints suggesting that the district look outside of New York State for ideas.
- Karen Lederman informed the board that Ira Share has been chosen as one of Newschannel 13's Top Teachers for 2011-2012.

• Mike Fortun told the board that he was not expecting a formal response to the letter he sent to the board earlier in the day on behalf of the BCEA. He was just reminding the board that the community group was still here.

#### **BOARD DISCUSSION/REPORTS**

- The board decided that the Priority Setting Survey should be made available online beginning January 27<sup>th</sup>. It will remain open for two weeks. A paper version will be mailed to all district residents at the same time. Mr. Wade drafted a letter to be sent to the Troy Record and The Advertiser announcing the survey. A notice has also been developed to send home with students notifying their parents of the upcoming survey.
- Mr. McIntosh asked the board to begin thinking about what tax levy they would be comfortable bringing to the community for the 2012 2013 budget.
