SUMMARY & BACKGROUND On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#). Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Funds must be fully liquidated by October 31, 2024. **Project Number** The project number stem for the program is: *ESSER: 5880 - 21 - XXXX*. This number should be used on the appropriate FS-10 budget form. **Submission Deadline** Completed applications are due by **August 31, 2021** (with extensions by request), and will be reviewed on a rolling basis. Please note that applications must be submitted and fully approved by no later than March 23, 2022. LEAs that have not been issued a Grant Award Notice by that time will be at risk of having their ARP-ESSER allocation returned to the United States Department of Education.

APPLICATION PROCESS FOR LEA ALLOCATIONS OF ARP-ESSER SEA RESERVE FUNDS The federal ARP statute requires SEAs to reserve:

- not less than 5 percent of the total amount of grant funds awarded to the State (\$449.4 million) to carry out activities to address the impact of lost instructional time by supporting the implementation of evidence-based interventions;
- not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based summer enrichment programs; and
- not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based comprehensive afterschool programs.

The 2021-22 enacted state budget directs that these required SEA set-asides be allocated as grants to specified school districts. DEPEW UFSD 140707030000 Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. The district engaged all Community stakeholders, faculty and staff through the use of an open-ended survey device called the thought Exchange. This allowed all stakeholder groups to generate ideas around the use of the funds as well as allowing them to rate other people's ideas. The superintendent shared the outcomes of these surveys with key leadership teams such as the Board of Education and the District Administrative team. The results of those meetings helped develop the spending plan. ----- The district offered a number of opportunities to the parents/community, and all employees using a variety of tools: 1. The use of an open-ended survey device called the Thought Exchange. This allowed all stakeholder groups to generate ideas around the use of the funds as well as allowing them to rate other people's ideas. Parent/community members and staff helped generate themes and ideas for the use of funds. 2. These were refined with internal teams made up of District leaders 3. There was also a presentation at the Board of Education, with an open forum that allowed all stakeholders an opportunity to have input on the spending plan. We will continue engagement using a similar methodology, leveraging technology, focus groups and the Board of Education along with a forum. The use of technology will allow the greatest number of participants to share in the safest manner.

The district is planning to use about 1.7 million dollars to improve air handling, filtration, and circulation for all 3 of the buildings in the district. An additional \$266,400 has been set aside for supplies that will be used for Covid-19 mediations, such as testing supplies.

We will identify student needs and progress monitor growth using assessment tools we have on hand including star reading, star math aimsweb, Running Records, classroom-based assessments, common formative assessments, parent and teacher input. ----- We will identify student needs and progress monitor growth using assessment tools we have on hand including star reading, star math aimsweb, Running Records, classroom-based assessments, common formative assessments, parent and teacher input. The interventions include but are not limited to: Math AIS and Literacy Support pull-out and push in programs (k-12), afterschool support programs (6-12), pre first grade (elementary), Counseling programs based on needs (k to 12), Wildcat Prep (9-12), Learning Lab (6-8) Progress monitoring will be completed quarterly (or as needed) using star reading, star math aimsweb, Running Records, classroom-based assessments, common formative assessments, parent and teacher input.

The District will be spending about 1.4 million dollars on salaries and benefits to hire additional staff. Due to the impact of loss of instructional time we are addressing gaps by hiring 3 literacy support teachers, 2 numeracy support teachers, and 1 social and emotional support counselor. They will be used to enhance our school day programs through focused academic intervention services, both pull out and push in. Our focus will be on developing math and literacy skills at both the elementary and middle school levels to better prepare students for the Regents exams they will face in high school. The counselor position is to dress the social emotional needs and the impacts of trauma that students have faced during the pandemic. Her work will be with high needs students in grades K to 5.

The District plans to spend all of its funding on Covid-19 mediations and addressing gaps due to the loss of instruction.

Proportionally impacted families within our district are the primary focus of our additional Staffing as described in the previous section. The at risk and neediest students have been identified and looking at the various data points described in a prior section. These data points show that students from low-income families, English learners and children with disabilities will be receiving the services. ----- Acadmic needs are being met through the hiring of additional Math, Reading, Literacy, English and a pre-grade 1 teachers to provide academic support, programs and services to identified students. Social emotional and mental health needs are being addressed through the hiring of an additional counselor to focus on those specific area. The entire counseking staff has spent time over the summer preparing for these needs. Having 2 at-risk/SEL counselors will focus on students who are attendance and academic concerns, allowing our entire staff more time with other students. Foster and McKinney Vento students have and will recieve extra services through their assigned counselors. At the middle school 3 grade level teachers have been paid a stipend to coordinate efforts for each grade level. Our current school district program already looks at low-income, students of color and SWD through their various data teams, with a focus on program/practice changes to better meet their needs. It is important to note we do not have migratory students.
