Regular School Board Meeting  
May 10, 2022

The Prescott School District Board of Directors met in a regular meeting session Tuesday, May 10, 2022 at 6:00 p.m. in the board meeting room located in building #5 on the junior high school campus.

The meeting was called to order by Mrs. Glass  
Bro. Palmer provided the opening prayer

Superintendent Poole acknowledged the accomplishments received by students through the athletic department in track, baseball and weight lifting.

**Expulsion Hearing**

Student State ID # 6746152624

President Glass opened the floor for the Hearing giving specific directions pertaining to the guidelines for the hearing.

**The purpose of the hearing:** To hear the recommendation of the Superintendent for the Expulsion of student, State ID #6746152624 for one calendar year regarding the incident based on Student Handbook Policy: 4.25 - Drugs and Alcohol.

According to the law the hearing is to be held in open session unless requested by the student or parent to be closed. The student, guardian/parent were not present for the hearing.

**The Hearing was held in an open session.**

The school board proceeded with the hearing and rendered the following action:

**Action:** Ryan Harvey made a motion to modify the Superintendent's recommendation for student #6746152624 to be expelled for a full calendar year with the modification and requirements being as follows:

- a) The Student has/submits a negative result drug test.

- b) The Student receives counseling and participates in a drug program. Verification is required of the student's attendance and completion in a counseling program and a drug program.
- c) The Student will be required to come before the school board before being reinstated. The school board will revisit the student's expulsion status to review his progress and completion of each requirement stipulated. Reed Koger seconded the motion to modify the recommendation as noted. Motion passed 5-0.

### **School Choice Applications (2022-2023 SY)**

Supt. Poole presented the school choice applications the district received for the 2022-2023 SY and asked the board to accept the applications.

**Action:** Altha Palmer made a motion to accept/approve the school choice applications received for the 2022-2023 school year. Reed Koger seconded the motion. Motion passed 5-0.

### **Licensed & Classified Personnel Policies-Adoption (ASBA Policy Updates 2022-2023 SY)**

Supt. Poole presented the Licensed and Classified personnel policy updates from ASBA for the 2022-23 SY. The Personnel Policy Committee (PPC) has reviewed and approved the updates. Mr. Poole recommended the adoption of the 22-23 personnel policy updates.

**Action:** Ryan Harvey made the motion to adopt the Licensed and Classified personnel policy updates for the 2022-2023 school year. Reed Koger seconded the motion. Motion passed 5-0.

### **2022-2023 Special Ed. & Related Services Application**

Supt. Poole presented the 2022-2023 Special Ed. & Related Services Application which includes the assurances and agreement and asked the board to approve the document.

**Action:** Altha Palmer made a motion to approve the 2022-23 Special Ed. & Related Services Application as presented. Reed Koger seconded the motion. Motion passed 5-0.

### **2022-2023 Proposed Certified Salary Schedule**

Supt. Poole presented the proposed 2022-2023 certified salary schedule to the board. The district would like to propose an increase to the certified salary schedule base by

\$1,100. All other steps on the salary schedule would increase accordingly. This increase will meet the mandatory BA and MSE base salary for Act 170-An Act To Create The Teacher Salary Enhancement Act required for the 2022-2023 school year. Supt. Poole informed the board that the PPC has reviewed and approves the proposed certified salary schedule for the 22-23 school year. Mr. Poole recommended the approval of the proposed 22-23 certified salary schedule.

**Action:** Michael Williams made a motion to approve the proposed 2022-2023 certified salary schedule. Ryan Harvey seconded the motion. Motion passed 5-0.

#### **2022-2023 District Treasurer**

Mr. Poole informed the school board that the district has received notification of the dissolution of the Valley View School District's Financial Service Cooperative on June 30, 2022. Supt. Poole stated that the district would like to appoint Kim Morman as District Treasurer effective July 1, 2022.

**Action:** Ryan Harvey made a motion to accept the recommendation of the Superintendent for appointing Kim Morman District Treasurer effective July 1, 2022. Altha Palmer seconded the motion which passed 5-0.

#### **2022-2023 Food Service Management Company - Aramark**

Supt. Poole recommended that the District continue using Aramark as the Food Service Management Company for the 2022-2023 school year.

**Action:** Ryan Harvey made a motion to accept the recommendation of Supt. Poole for Aramark to be the district's Food Service Management Company for the 2022-2023 school year. Reed Koger seconded the motion. Motion passed 5-0. .

Michael Williams made a motion to approve the minutes of the April 12, 2022 regular school board meeting. Ryan Harvey seconded the motion. Motion passed 5-0.

**b) Sale of Portable Buildings - Permission to Take Bids**

Supt. Poole asked the board for permission to take bids for the sale of the three portable buildings located at the elementary campus.

**Action:** Michael Williams made the motion to grant Mr. Poole permission to take bids for the sale of the three portable buildings located at the elementary campus. Ryan Harvey seconded the motion which passed 5-0.
