- 9. Dean's Report: Mike shared the Dean's Report. Karyn Bethke and Robin Nielsen have resigned. There were some fantastic candidates and interviews are done. 8th grade graduation parade was last night. The final video for the school year is completed and shared with families. A survey went out to teachers for opinions on EL Education.
- 10. Fiduciary Report: Armstrong Driving School would also to use our building over the summer with the possible use of the gym instead of a classroom. Special Education review findings will require some wording changes and correction to number used to bill Medicaid. Alli discussed each item on the budget for next school year.
