

Lockney Independent School District Vendor Application Form

Instructions:

The application form should be completed and signed by an authorized representative of the vendor.

The applications should be submitted (as noted below) with all supporting documents, including but not limited to:

- a. W-9 Form
- b. Conflict of Interest Questionnaire
- c. Felony Conviction Form
- d. Certificate of Insurance (as appropriate for on-site professional services)
- e. Certification of Criminal History Record Information (if working directly with students)

Notice to Prospective Vendors:

- Vendors are not placed on the district's approved vendor list until a purchase order is approved by the purchasing department.
- Vendors must accept purchase orders for all purchase. The district will <u>not</u> be responsible for payment for goods or services that are provided to Lockney ISD staff without an approved purchase order issued by the purchasing department.
- 3. All invoices must reflect the purchase order number and must be mailed, faxed, or emailed to the Lockney ISD Accounts Payable Department (mailing address, fax number and email address are noted below).
- 4. All payments are net 30 days after receipt of the goods and/or services.
