SUPERINTENDENT'S REPORT

The FY 19 spreadsheet shows that the State owes the District \$51,995.86 in 4th quarter reimbursement for special education, driver's education, and both transportation claims. Also, they owe us some EC money for a new allocation they provided in June. Nearly all grants have been written and submitted to ISBE for FY 20. Since we do not typically receive state or federal money in July (unless it's past due), an FY 20 spreadsheet is not available until next month. The State still has not provided us any updates on new funding for FY 20 even though the State budget was adopted by the General Assembly in a timely fashion and signed by the Governor. Everything with NPT Special Education Cooperative is going well. The new accounting software (SDS) has been successfully uploaded and we are transitioning and learning.

Summer Projects Update:

- a. North School: Walls are up and painted, floors should be done by 07/26/19. During the week of July 15 & 22, they should finish up most of the electrical, some plumbing, painting, and exterior blacktop. It is coming along nicely. Carpet will be installed around July 31 for the Library. Some furniture has arrived, but new bookshelves will not be delivered until early August.
- b. The tile around the New Gym floor will be started the week of July 22.
- c. The EC pavilion is completed.

- d. The exterior water sealant and new tile has been installed and ready to be re-blacktopped. The old tile was found, under the foundation, it was kept in-tact and the new tile is sitting on the exterior foundation flowing into the new lines. I think they did a great job a double barrier of water protection was placed on the exterior underground walls. Once exposed, we were able to see all the cracks in the brick wall around the building, which probably was some of the cause of the water penetration.
- e. Gutters should start being fixed in late July or early August.
- f. Finally, custodians are doing a great job of getting the buildings cleaned, waxed, and ready for school to start.
