The Council for Better Education, along with Frankfort Independent and Warren County Schools, has filed litigation regarding the unconstitutionality of the private school tax credits in HB563. They are only challenging the tax credits portion of this bill, which would use public money to fund private education. CBE is asking that each board of education adopt a resolution in support of their efforts. They are also asking that each district financially support their efforts at a proposed assessment of 50 cents per pupil in order to pay the legal and related costs associated with this process. This would be a cost of 181.13 for Jenkins Independent. The Jenkins School Reopening Plan for 2021-2022 was submitted for approval.
