# 3. Superintendent/Board Member Communications

Legislative Updates HB 563 does away with non-resident contracts between districts and allows all districts to adopt a policy governing enrollment of non-resident students, and to receive SEEK funding for all non-resident students enrolled. HB 258 creates a new tier of benefits for members of the Teachers Retirement System (TRS) who join the system for the first time after January 1, 2022. The new tier requires TRS members to work until age 57, with 30 years of service before being eligible for full retirement benefits. The bill does not affect current TRS members or TRS retirees. HB 128 provides for a supplemental year for all Kentucky students, allowing them to retake courses or supplement courses already taken. Local boards are not required to provide the supplemental year but, if they do, they must allow all students who wish to participate to do so. In the final hours of the legislative session, school districts were given \$140 million in funding for full-day kindergarten for the 2021-22 school year.
