President Mark Johnson called the meeting to order at 7:01 p.m. Following the Pledge of Allegiance, roll call was taken. Present were Board Members Mark Johnson, Larry Kelley, Tyler Aspenson, Rachael George, and Chad Sime. Also present was Administrator David Boland. Excused: Charles Clark and Shawn Lenzendorf.

- I. Rachael George made a motion, seconded by Mark Johnson to approve the final budget, with set expenditures and revenues. Motion carried 5-0.
- II. Chad Sime made a motion, seconded by Larry Kelley, to approve a Fund 10 tax levy of \$1,621,323; and a total tax levy of \$1,662,011 for the 2019-2020 school year as presented. Motion carried 5-0.
- III. Larry Kelley made a motion, seconded by Tyler Aspenson, to approve a 66.0301 shared services agreement with Monroe School District for speech services for the 2019-2020 school year. Motion carried 5-0.

Administrator's Report:

• **A. Financial:** *Donation:* In early October we received \$6,160 worth of supplies, through the "3M Supplies for Schools" program. We have been told this gift is courtesy of the 3M plant in our community. Thank you to them! This is the fourth year we have received a donation from them. *SEF:* The Educational Foundation recently donated \$1,800 for a classroom set of Ozobots

(small robots that can be coded) for Donna Aspenson, and \$480 for a rug for Michaela Chambers classroom. We appreciate all the SEF has done for our school!

- **B. Maintenance:** *Projects:* Dave Foley has installed an exterior light on the north side of the gym, replacing the light moved during the summer project. We are getting bids on two furnaces in the elementary. We ordered a load of mulch, for the elementary playground.
- *Phone System:* We upgraded the service contract, backed up the system, and replaced the main server for our phone system with Centurylink, at a cost of \$5,604. We were having problems with the old server, which we calculate was over twelve years old. With this upgrade, our phone system should last us another 5-6 years.
- C. School News: CPR training: 8 coaches and staff members attended a CPR refresher course Wed, Oct 9. Thanks to Ashley Roberts of the Seneca First Responders for training them. Flu shots: A flu clinic was held in the gym lobby for students on Wed, Oct 16. Staff received vaccinations Oct 22.

Fall Festival: The elementary Fall Festival will be held Sat, Oct 26 from 10:00 a.m. to noon. The event is sponsored by the elementary Parent-Teacher Group.

Blood Drive: The fall blood drive, sponsored by the National Honor Society, will be Wednesday, December 11.

DLL: During the first semester of the school year, there are 2 students taking 1 course in the distance learning lab (Parenting). There are 16 students taking 21 online courses (15 Wisconsin Virtual School courses; 6 Southwest Tech online courses).

Staff Responsibilities: A list of staff members was distributed, with many of their responsibilities listed.
