- **1. Welcome:** Ricky Emerson welcomed all to the meeting, reviewed meeting protocol and verified a quorum of board members were present. Those in attendance were Mrs. Emerson, Heather Muir, Sandra Freitas, Darla Mullins, Joel McMahan, Dr. Paul Farris, Angela Bowen and Nancy Nebeker.
- **2. Call to Order:** Mrs. Emerson called the meeting to order at 6:00pm and asked Mrs. Freitas to lead all in the Pledge of Allegiance.
- **3.** Changes or Additions to the Agenda: Dr. Farris requested the addition of Consent Agenda 8.C., ESD 113 Accounts Payable Olympic Academy Payment in order to reapply for Safety Net before the deadline. Dr. Farris also requested the addition of the following for Personnel Action:

- **4. Approval of Minutes:** Mrs. Freitas made a motion to approve A., June 2022 Regular Meeting Minutes; B., July 2, 2022 Special Meeting Minutes; C., July 14, 2022 Budget Workshop Minutes. Mr. McMahan seconded. The motion passed unanimously, (5, 0).
- 5. Audience and Communications: None.
- **6. School Spotlight:** Dr. Farris introduced Tracy Dorr Elementary Principal, and shared a about her previous 30 years of background in education. Mrs. Dorr expressed her love for small communities and passion to mentor teachers, helping them to succeed.
- **7. Budget Overview:** Mrs. Bowen presented the June 2022 Financial Report. Mrs. Muir made a motion to approve Resolution 22-2, 2022 2023 Budget and Four-Year Projection. Mrs. Mullins seconded. The motion passed unanimously, (5, 0).

- **9. Presentations:** Dr. Farris presented the Superintendent's Report. He updated the board with summer grounds projects, the new playground, safety and security measures, the weight room and closed by sharing about 2022 Discovery Team.
 - Mrs. Freitas provided a legislative update, sharing that the next WWSSDA General Assembly will be held the end of September with the WSSDA Conference following in November.
- **10. Dr. Farris expressed the Illustrative Mathematics is currently being reviewed for possible adoption at a future date for the secondary school. A hard copy will be at room 205 for public viewing as well as posted on the website.

High School Principal, Chris Schumaker presented the district wide 2022-2023 Highly Capable plan. Mr. McMahan made a motion to approve C., The Highly Capable Plan for the 2022-2023 school year. Mrs. Mullins seconded. The motion passed unanimously, (5, 0).

Mr. Schumaker presented the 2022-2023- and five-year CTE plan for JH and HS students. Mrs. Freitas made amotion to approve the 2022-2023- and five-year CTE plan as presented. Mr. McMahan seconded. The motion passed unanimously, (5, 0).

Dr. Farris explained the MWP Interlocal Agreement has been presented to the board for it's first reading to be possibly adopted soon.

Dr. Farris closed the New Business portion of the regular meeting be stating he hopes we will hold a surplus sale in August or September of this year.

Mr. McMahan made a motion to approve Sandra Freitas School Board Director position #4 resignation as of July 19, 2022. Mrs. Mullins seconded. The motion passed unanimously, (4, 0). Mrs. Freitas declined to vote.
