- **2. Call to Order:** Mrs. Emerson called the meeting to order at 6:00pm and asked Mr. McMahan to lead all in the Pledge of Allegiance.
- **3.** Changes or Additions to the Agenda: Dr. Farris requested the addition of 15C, Chris Dantine, MWP Volunteer Jr High Baseball Coach for the 2022 Season.
