PPEL Vote September 11, 2012

A friendly reminder that the Turkey Valley School District will hold the Physical Plant and Equipment Levy vote on Tuesday, September 11, 2012, from 12:00-8:00 p.m. in the Elementary Library. This is a very important vote for the school district as the monies that are generated through this vote are used for a variety of purposes. These purposes include: Purchase and improvement of grounds; construction of schoolhouses or buildings and opening roads to schoolhouses or buildings; purchase of buildings and the purchase, lease, or lease-purchase of a single unit of equipment or technology exceeding \$500 in value; payment of debts contracted for the erection or construction of schoolhouses or buildings, not including interest on bonds; procuring or acquisition of library facilities; repairing, remodeling, reconstructing, improving, or expanding the schoolhouses or buildings and additions to existing schoolhouses; expenditures for energy conservation; rental of facilities under chapter 28E; purchase of transportation equipment for transporting students; lease-purchase option agreements for school buildings; equipment purchases for recreational purposes; and payments to a municipality.

The tax rate for the voter approved PPEL will remain the SAME as in the past. This amount is 0.67 cents per thousand dollars of property valuation.

This school year I welcomed the staff back with a presentation about coming together as a TEAM. This acronym means: Together Everyone Achieves More. I stressed the importance of banding together and remaining united. I also stressed how teams treat and act towards one another, students, parents, and community. July Special Board Meeting



New Outdoor Warning Siren in Jackson Junction

The City of Jackson Junction, with the help of two grants, has purchased an outdoor warning siren. Please be aware of this siren when you attend Turkey Valley events. This siren will go off around 6:00 PM every night and will last around seven seconds. If there is a case of imminent damaging weather or tornado the siren will go off for three minutes. If you hear the siren blast for three minutes, seek shelter.

Thank you to the town of Jackson Junction and the city council for implementing this warning system. It will benefit not only the town of Jackson Junction but also Turkey Valley, Jackson Heights Golf Course, and it can be heard for miles surrounding Jackson Junction.

Dear Parents,

Children need healthy meals to learn and grow. For almost 70 years, the National School Lunch Program has been serving meals to our nation's children, with the original concept of ending malnutrition and child-hood hunger. This past year, with the passing of the Healthy-Hunger Free Act of 2012, school food finally has received the attention it deserves in relating to its importance in helping kids succeed in school and providing a foundation for lifelong healthy eating habits. As a result of this new law, schools have been charged to create healthier meals that contain more whole grains, vegetables, and fruits, and less fat and sodium and set sensible calorie limits based on the age of children.

The Healthy-Hunger Free Act of 2012 requires the following:

A child must choose a minimum of ½ cup of either a vegetable or fruit each day. The lunch price will not change if both are chosen, so encourage your child to select a vegetable and a fruit for the healthiest lunch tray. In addition, they must choose two other lunch components for a meal.

A wider variety of vegetables are now being offered. Encourage your child to try a new vegetable choice – especially dark green, red, and orange veggies and beans/peas.

Breads and grains served are transitioning to whole grain. By school year 2014-15, all grains will whole grain-rich.

The types of milk offered are now required to be fat-free (unflavored or flavored), low-fat (unflavored only), fat-free or low –fat lactose –reduced or lactose-free.

Calories, sodium and saturated fats are now required to be within a certain range, depending on your child's grade level.

Our school food service staff member, in conjunction with the School Wellness Team, are working very hard on educating students and staff about healthy living habits and the importance of trying new foods with support from the Northeast Iowa Food and Fitness Initiative. We are trying to purchase as much local, fresh food as possible, while keeping school lunch prices low.

You can help support our efforts by encouraging your child to eat fruits and vegetables at home and building healthy habits into your day.

We look forward to a happy healthy start to school in the fall!

4. Students may eat and drink on the bus if they keep the bus clean.
5. Remain seated
6. Keep your hands and head inside the bus.
7. Treat all property with respect.
8. At railroad crossings, stop signs, and turn-arounds, be quiet so that the driver can listen and proceed safely.
9. For your own safety, do not distract the driver through misbehavior.
10. During evacuations and actual emergencies students must be quiet and paying attention for further instructions. Pictures or videos on electronic devices NOT allowed during these times.

Any activity that worries or distracts the driver is objectionable. If the bus driver is worried about the activity in the bus, he/she cannot be a safe driver. Transportation equipment is expensive and students are expected to cooperate in its maintenance and preservation. All passengers need to cooperate for safety and efficiency. A student's bus riding privileges may be suspended immediately when the student's presence poses a continuing danger to other person or property, or an ongoing threat of disrupting the safe transportation of students.







- May 3—for the June 8 testing date


The basic fee for ACT (no writing test) is \$35. The school code for Turkey Valley is 162-435.

Notice to Parents

Destruction of Special Education Records—The federal General Education Provisions Act requires retention of records for three years after the completion of an activity to which federal funds are used. 
