A. INTRODUCTORY BUSINESS

- 1. The meeting was called to order at 7:00 p.m. by Chairman Vance Pineo, Jr.

- 3. RE: REPORT—SUPERINTENDENT OF SCHOOLS (Including Legislative Updates)
 INFORMATION: Supt. Ramsay noted that we are expecting guidance from the governor soon about opening schools in September. The CDC guidelines he has seen so far, he does not feel are doable, but we will have to work with whatever they direct. We did receive guidance on the budget process and are moving forward with our District Budget Meeting on June 16th at the high school. There are several CDC guidelines we must follow. The validation referendum will be on July 14th.—There are 12 school days left in this year but ending the way we have had to has not been easy. The A-team met yesterday to make plans on how to conclude the year for students and staff.—One year ago today, we signed the paperwork to move forward with the CTE project. Tonight, Supt. Ramsay hopes to have three of the four teacher positions filled. Construction is going well, and we are still on track with our timeline.

6. RE: APPROVAL OF 2020 HIGH SCHOOL GRADUATION PROGRAM

ACTION: Supt. Ramsay noted that we cannot do things as we normally would for graduation. We must follow state guidelines on what we can do and that does not allow us to fill a gymnasium with 1,000+ people. He and the high school administration have discussed waiting, but the longer things have gone on, the more apparent it is that the state will not allow us to hold a "normal" graduation anytime this summer. He, Mrs. Day, and Mr. Emerson looked at many options and came up with the best-case scenario, given the variables.

A graduation will be held on June 5th at 2:00 p.m. The entire Senior class (36 students) will be present, as well as a few administrators. The ceremony will be live-streamed. As each graduate receives his/her accolades, eight family members will be allowed to enter the gym, take photos, and then exit at the other end of the gym. Then the next family will come in to watch their graduate. Everyone understands it is not idea, but it is a better option than many others. If any new guidance is received from the state in the next few days that will allow expanding that number, we certainly will do so.

In addition, he noted that many on the board had heard about the pushback on the senior class fund. This is an unprecedented year where the class is unable to do anything to spend the money they've raised for a class trip, prom, etc. The district will not be keeping these funds. Some will be set aside to pay the expenses that have been incurred for graduation, senior gifts, etc. but the remainder will be divided equally among the 36 graduates and presented as a Class of 2020 Scholarship at graduation.

Motion by Mark Wright, second by Grace Kennedy, and voted (unanimously) to approve the 2020 Graduation program and Class of 2020 Scholarship.

A reminder that the June meeting will be held at Narraguagus, not on Zoom.
