The district will be switching from air conditioning to heat soon. Grants were received to cover the costs of new doors and locking mechanisms at the high school. Mrs. Thompson captured these grants to cover the costs. "Roadmap to literacy" was updated by Mr. Favre. The administration and staff are working on creating and establishing this action plan for students. New Reading curriculum will be presented for approval at the November meeting. Students were asked to vote on their favorite playground design for the new elementary 2-5. Mr. Heigert rand the study and presented the winning design. Dr. Tepen presented the Board with the master schedule changes and ideas to bring the "Middle" School back to a "Junior High" concept. Schedule and shared staff with the high school would allow students more opportunities for elective classes. Mrs. Ellis gave her presentation on "Portrait of a Graduate".
