The Litchfield Board of Education held a special meeting beginning at 6:00 p.m. at the District Office-1100 N. Old Route 66, Litchfield, IL. New Business

Ben Eveliser of Poettker Construction presented the bids to the Board of Education for the South Central Illinois Training and Innovation Center. The bids came in approximately \$1 million under budget. This allowed for alternate packages to be included.

A motion was made by Ron Anglin and seconded by Mark Bloome to award bid package #1-- General Trades to Litteken Construction Company, LLC. in the amount of \$1,370,600.00. Roll Call Vote: YEA: Abel, Anglin, Belusko, Bloome, Cain, Gorowski. Motion carried 6-0.

A motion was made by Ron Anglin and seconded by Valerie Cain to award bid package No. 2- Metal Studs, Insulation, Drywall & ACT to Von Alst Operating, LLC. in the amount of \$1,113,173.00. Roll Call Vote: YEA: Abel, Anglin, Belusko, Bloome, Cain, Gorowski. Motion carried 6-0.
