This fiscal year, N-C spent \$1,126,734 in the education fund compared to \$1,185,542 last year. In the operation and maintenance fund, the district spent \$196,036 compared to \$545,486 last year. The district spent \$105,890 in the transportation fund this year compared to \$189,898 last year. The district spent \$1,428,660 this year compared to \$1,920,926 the previous year in those three funds for a difference of \$492,266 less this year compared to last year. The district has spent \$1,740,679 this fiscal year compared to \$2,228,246 last year. The district spent \$487,567 less this year compared to last year in all the funds.

November 30, 2022, completed 42 .0% of the 2022 fiscal year. The district expended 33.5% of the education budget, 54.2% of the operations and maintenance budget, and 25.9% of the transportation budget.

Fund balances as of November 30, 2022: Education: \$2,972,567, Operation and Maintenance: \$228,157, Transportation: \$430,770, and Working Cash: \$138,592. The four Major Fund Balances: \$3,770,086 Total Fund Balance for all funds: \$4,491,488.

Fund balances as of November 30, 2021: Education: \$2,674,346, Operation and Maintenance: \$211,985, Transportation: \$465,611, and Working Cash: \$107,619. The four Major Fund Balances: \$3,351,942. Total Fund Balance for all funds: \$4,173,281.

The district has \$418,144 more this year compared to last year in the four major funds. In addition, the district has \$318,207 more this year compared to the previous year in total fund balance.
