This fiscal year, N-C spent \$1,374,696 in the education fund compared to \$1,465,250 last year. In the operation and maintenance fund, the district spent \$215,292 compared to \$665,205 last year. The district spent \$184,558 this year in the transportation fund compared to \$230,474 last year. The district spent \$1,774,546 this year compared to \$2,360,929 the previous year in those three funds for a difference of \$586,383 less this year compared to last year. The district has spent a total of \$2,110,771 this fiscal year compared to \$2,692,012. The district spent \$581,241 less this year compared to last year.

December 31, 2022, completed 50% of the 2023 fiscal year. The district expended 40.8% of the education budget, 59.5% of the operations and maintenance budget, and 45.1% of the transportation budget.

Fund balances as of December 31, 2022: Education: \$2,785,103, Operation and Maintenance: \$195,822, Transportation: \$386,859, and Working Cash: \$138,608. The four Major Fund Balances: \$3,506,392. Total Fund Balance for all funds: \$4,204,703.

Fund balances as of December 31, 2021: Education: \$2,466,951, Operation and Maintenance: \$92,272, Transportation: \$425,071, and Working Cash: \$107,629. The four Major Fund Balances: \$3,091,923. Total Fund Balance for all funds: \$3,782,081.

The district has \$414,469 more this year compared to last year in the four major funds. In addition, the district has \$422,622 this year compared to the previous year in total fund balance.
