This fiscal year, N-C spent \$1,550,944 in the education fund compared to \$2,110,066 last year. In the operation and maintenance fund, the district spent \$242,864 compared to \$708,467 last year. The district spent \$204,785 this year in the transportation fund compared to \$284,068 last year. The district spent \$1,998,593 this year compared to \$3,102,601 the previous year in those three funds for a difference of \$620,576 less this year

compared to last year. The district has spent a total of \$2,350,390 this fiscal year compared to \$2,695,828. The district spent \$345,438 less this year compared to last year.

February 28, 2023, completed 67.0% of the 2023 fiscal year. The district expended 60.8% of the education budget, 74.4% of the operations and maintenance budget, and 55.9% of the transportation budget.

Fund balances as of February 28, 2023: Education: \$2,614,345, Operation and Maintenance: \$142,047, Transportation: \$342,506, and Working Cash: \$138,630. The four Major Fund Balances: \$3,237,528. Total Fund Balance for all funds: \$3,909,055.

Fund balances as of February 28, 2022: Education: \$2,428,481, Operation and Maintenance: \$191,508, Transportation: \$422,657, and Working Cash: \$107,647. The four Major Fund Balances: \$3,150,293. Total Fund Balance for all funds: \$3,809,276.

The district has \$87,235 more this year compared to last year in the four major funds. In addition, the district has \$99,779 more this year compared to the previous year in total fund balance.

6.0 Recognition of the Members of the Audience

6.01 Public Comment

Mrs. Trisha Mitchell and Mr. Josh Mitchell approached the board with concerns about junior high sports. They are concerned with the possible number of students participating in the upcoming years and whether we would be able to field teams. Ms. Feikert is concerned on the girls' elementary side, their numbers are also low. They questioned whether other schools could be approached about possible sports co-ops and if home school students could be approached. Discussion followed on the subject. The board told the parents they are welcome to approach other school boards on the subject. The board reminded them that the process could take a year or two due to contracts that are renewed for a 2-year period.

The other 2 open positions will be filled in the same manner. Mr. Young will contact the ROE on the situation.
