This fiscal year, N-C spent \$2,723,876 in the education fund compared to \$2,748,499 last year. In the operation and maintenance fund, the district spent \$318,630 compared to \$770,359 last year. The district spent \$280,324 in the transportation fund this year compared to \$341,280 last year. The district spent \$3,322,830 this year compared to \$3,860,138 the previous year in those three funds for a difference of \$537,305 less this year compared to last year. The district has spent \$3,799,331 this fiscal year compared to \$4,293,353 last year. The district spent \$494,022 less this year compared to last year.

May 31, 2023, completed 92.0% of the 2023 fiscal year. The district expended 80.9% of the education budget, 88.1% of the operations and maintenance budget, and 68.4 % of the transportation budget.

Fund balances as of May 31, 2023: Education: \$2,163,256, Operation and Maintenance: \$152,123, Transportation: \$393,118, and Working Cash: \$112,588. The four Major Fund Balances: \$2,821,085. Total Fund Balance for all funds: \$3,350,614.

Fund balances as of May 31, 2022: Education: \$2,253,944, Operation and Maintenance: \$129,655, Transportation: \$415,804, and Working Cash: \$107,674. The four Major Fund Balances: \$2,907,077. Total Fund Balance for all funds: \$3,494,164.

The district has \$85,992 less this year compared to last year in the four major funds. In addition, the district has \$143,550 less this year compared to the previous year in total fund balances.
