1169. SUV BIDS and FY2020 Bus/Vehicle Replacement Plan

Coy Sasse provided a summary of total cost of the vehicle replacement plan for FY 2020. He also presented the only bid received for the SUV Request for Proposal issued in February 2019. The bid was submitted by McKie Ford, with a unit price of \$42,889; for an overall cost of \$257,334.
