I transferred my kids from private to public \sim 3 years ago and have publicly advocated for parent participation and transparency. In a climate of public distrust and friction, I am volunteering my time and service to participate in a solution.

I have invested countless hours researching programs and processes in our district; my participation speaks for its own. My primary goal is district success, to change the tone from defensiveness to acknowledgment. Success also includes public access and dialog beyond board meetings. Board meetings are more of a public broadcast than dialog. I am willing to establish board committees where public dialogue is encouraged.

3. Identify the most significant issues in public education generally and in the Ojai Unified School District specifically. State the ways you believe the District should respond to these issues.

The school's funding formula needs to be revised. Most school funds are tied to goals and actions for student achievement. Unrestricted funds generally provide a base action to accomplish a goal, and restricted funds generally provide an enhanced effort to achieve a goal. Ojai's goals and actions could be more specific and concise. Specific actions promote transparency and, from a financial perspective, will simplify the separation of restricted and unrestricted funds.

Teachers in our district must be paid for all of their time beyond the one-year service credit. OjaiUSD should offer a Defined Benefit Program to supplement retirement. (https://www.calstrs.com/defined-benefit-program)

4. What do you see as the major responsibilities of a Board Member?

As a school board member, your primary responsibility is to ensure that the district provides high quality education to its students. The Board is responsible for setting policies and making decisions about the district's budget, curriculum, facilities, and personnel.

Trustees are accountable to the community and represent the interests of district's students, parents, and taxpayers. The superintendent works with the district staff to implement the policies and decisions made by the school board and is accountable to the board for the district's performance

The relationship between school board members and district administration should be collaborative and constructive, with both groups working together to address school concerns in the best interest of the students and the community.
