- 1. Over the past six months, I have played an active role in all public meetings related to our districts fiscal crisis. I took the position that our superintendent was ultimately responsible for the position we found ourselves in. However, the role of superintendent reports to the school board and the board itself must also shoulder some of the responsibility. I was also critical of the candidate the board voted to approve as interim superintendent. Ultimately, my role along with many others in our community led to the resignation of our superintendent and two board members. My interest on serving on the board is to help in rebuilding what has been dismantled. Part of that process will be restoring trust with the community. A critical piece of that trust and re-building process will be the vetting and hiring of the next superintendent.
- 2. My commitment and interests are rooted in the children of our community, including my own who attend schools in Ojai Unified. I believe a thriving community must have a thriving public school system that not only prepares our youth to take the next step in their academic career, but also provides multiple avenues to explore outside the classroom through community involvement, clubs, athletics, and the arts. The district should constantly be working to provide and support these opportunities.
- 3. Funding and fiscal responsibility, along with providing and meeting the needs of every child to prepare them in their next stage in life are the most important issues that public-school face. Our district clearly ran into some problems relating to fiscal responsibility. Balancing our budget and prioritizing our funding where it matters most are the key to meeting these challenges.

If we want to prepare students we need to prioritize hiring and retaining the best teachers. This should be one of the most important factors as it relates to budgeting. Developing holistic programming outside the classroom also needs to be factored related to budgeting. When we have shortfalls as it relates to enrichment programs, we should work creatively to raise the necessary funds to meet these needs and steward those funds responsibly. A large portion of our funding is based on enrollment. The stronger the academics and enrichment programs are, the more likely folks will choose to enroll their kids in our public schools. We also need to make sure we are doing everything we can to tackle the attendance issues in our schools.

- 4. Hiring and holding our administration accountable for the success of the district is a major responsibility. As a board member you are also responsible to stay informed as it relates to all decisions the board is required to vote on. It is also important to involve our community in major decisions and build trust with all our stakeholders through transparency and professionalism.
- 5. In general, boards are elected by the community to set priorities, establish policies and evaluate the outcomes of district operation. Superintendents identify needs and policies, develop regulations, provide leadership, and manage the day-to-day operation of the district.
- 6. Like all relationships, it should be based on trust and transparency. The success of our school district is the goal and is in the best interest of both the board and the administration. The approach should be to solve problems together.

- 7. I have three current students in the district at both the elementary level and the middle school/high school level. I think this adds great value as to what is important to all the parents of this community. I also run my own optometry practice. Running a small business requires you to solve problems, learn to manage relationships, manage resources, along with developing many other operational and leadership skills.
- 8. I will admit I have not been as involved as I would have loved to be in the past 7 years. I took over my practice five years ago and have had to invest a lot of energy in that pursuit as well as being a mother and wife. I am fortunate at this time that my practice has not only survived the Thomas Fire as well as COVID but that I am in a situation that I am able to pull myself away from it more now than I was able to previously.

The most recent volunteering I have done is in the classroom of my two younger children. I helped in their art class and also a Meadow Walk. I have attended all but one board meeting since I started going several months ago.

- 9. I am affiliated with the Lions Club and offer heavily discounted exams and eyeware to the organization for any child they deem is in need of such services. I have donated sunglasses and services to Meiners Oaks Elementry for auctions as well as Beat the Streets, a non-profit my husband works for. I have also volunteered at many Beat the Streets events handing out gear for the athletes the non-profit serves.
