Of particular interest was how students could be profoundly affected by opportunities the Career Technical High School will provide, offering students the ability to study courses and receive training in a variety of technical areas not offered at a traditional high school. 0094. Personnel

- b) Approving the recommendation to offer Woody Begay a contract as Resource Officer;
- c) Offering a contract to Nora Farland as Accounting Assistant; with Candy Bornsen as alternate.

0095. Bids

Motion by Two Crow, seconded by T. Conroy to accept bids and offer contracts for services for the 2018-19 school year, as follows:

a) Garbage Pick-up and Disposal

Salomon Sanitation in the amount of \$6,600.00 per month, for district-wide garbage pick-up and disposal, as per bid.

b) Propane (small tanks throughout district)

Westco, Alliance, NE, in the amount of: \$1.44 per gallon (fixed price) to provide propane to the district' small tanks at district housing and teacherages;

c) <u>Diesel and Gasoline</u>

Westco, Alliance, NE, in the amount of 2.685 per gallon for regular unleaded gasoline; 2.956 per gallon for diesel fuel #2; and 3.165 per gallon for diesel fuel #1 to all four school sites (all gasoline & diesel fixed price).

d) Milk

Avera/PACE/Dean Foods in the amount of .1849 for 1% milk ½ pints; .1935 for skim milk ½ pints; and .1849 for chocolate skim milk ½ pints.
