0049. <u>Annual Budget Hearing</u>

Business Manager Coy Sasse invited input from the public or staff in regard to the 2018-19 budget.

0050. <u>Approval of Agenda</u>

0051. <u>Approval of Minutes</u>

Motion by Two Crow, seconded by C. Conroy to approve meeting minutes of June 26, 2018 regular meeting; further, to approve the Annual meeting minutes of July 10, 2018, with the following correction: Board member Robert Two Crow should be listed as "Absent." The School Board reviewed and discussed Principal and Administrators reports. Motion by T. Conroy, seconded by Two Crow to approve Administrators reports.

0053. <u>Data Presentation</u>

Ms. Connie Kaltenbach, Director of Curriculum, Instruction & Assessment presented results of MAP Assessment math and reading scores. Ms. Kaltenbach reported that student Math and Reading goals were met for 2017-18, and test results shows student academic growth. Ms. Kaltenbach then reviewed student test results per school. Motion by T. Conroy, seconded by Two Crow to approve a contract for Technical Advisor, Ms. Katie Bray, assigned by the South Dakota Department of Education, in the amount of \$35,500.00. Motion carried. (Attachment E)

0061. <u>Parent Involvement Insert</u>

Motion by C. Conroy, seconded by Two Crow to approve Lakota Country Times to continue providing the Parent Involvement Insert in their newspaper for the 2018-19 school year. Motion carried.

0062. <u>Disbursements</u>

Motion by Two Crow, seconded by C. Conroy to approve disbursements, as presented by the Business Manager, in addition to payments to US Bank New Market Tax Fund Engagement Agreement in the amount of \$25,000.00, and a payment to Solomon Sanitation in the amount of \$6,666.00. Motion by C. The school district will establish a direct charge account that B.E.A.R. may purchase food on for second half of the program, up to \$2,250.00.
