# OGLALA LAKOTA COUNTY SCHOOL BOARD REGULAR MEETING TUESDAY, FEBRUARY 27, 2018 ROCKYFORD SCHOOL

#### **MINUTES**

#### 0281. <u>Executive Session</u>

#### 0282. <u>Reports</u>

The School Board reviewed and discussed Principals and Administrators reports. Motion by Zephier, seconded by Conroy to approve school board reports, as presented. Motion carried.

#### 0283. Ketel-Thorstenson

Jean Smith, of Ketel-Thorstensen Accounting Firm, was in attendance to provide the school board and administration information in regard to establishing 503© non-profit status for a fundraising Foundation to assist with district projects and interests. Ketel Thorstenson would be willing to assist the school district in devising and reviewing a business plan for the Foundation, internal control processes, and approval of 10-23 tax exempt status. #### 0284. <u>Personnel</u>

Motion by Zephier, seconded by Two Crow to approve personnel recommendations, with a modification to accept resignation of Ms. Sherry Palmier, Rockyford Special Education Aide. Motion carried. (Attachment C)

#### 0285. <u>Financials</u>

Motion by Zephier, seconded by Conroy to approve the financial report and disbursements, as presented by the Business Manager, with the additional payments to Schoology in the amount of \$10,000.00 and Katie Bray, Teachnical Advisor, in the amount of \$2,700.00. Motion carried. (Attachment D)

#### 0286. <u>OST Health Administration</u>

Mr. Jacey Twiss was in attendance to provide the school board information in regard to the MOA the school board approved and entered into with the OST Health Administration during the 2017-18 school year. The OST Health Administration requested that Rockyford School be designated as the school to receive services at this time, hopefully, adding additional school sites in next year's Memorandum of Agreement.

Motion by Two Crow, seconded by Conroy to approve the revised Memorandum of Agreement with the Oglala Sioux Tribal Health Administration, designating Rockyford School as the school receiving services. Motion carried. (Attachment E)

#### 0287. <u>Engagement Agreements</u>

Motion by Zephier, seconded by Two Crow to authorize the school district entering into an Agreement of Engagement with Ketel-Thorstenson Accounting. LLC, in addition to GPNA legal firm, to assist in the formation of a school district fund-raising Foundation. Motion carried. (Attachment F)
