CALL REGULAR BOARD MEETING TO ORDER AND ROLL CALL.

SUPERINTENDENT'S REPORT

So, the monthly spreadsheet shows the state owes us \$154,141.79, but that also includes the 4th quarter mandated categorical payments that are due on June 30, 2020. However, surprisingly, the State made their 3rd quarter MCAT payments last week. State aid funding is on track to be paid for the fiscal year, but other state payments are behind, at this point, by 1 payment, we did receive some Early Childhood money in the past month. I do expect federal grant money along with breakfast and lunch federal money. The General Assembly passed a budget and the Governor signed it on 06/10/2020. It calls for level funding for schools in all categories; however, the state budget is dependent on either borrowing from the federal government or hoping Congress provides additional COVID funding for local government (states) AND the passage of the graduated income tax increase. The budget bill calls for a Commission to be created to look at the budget if none of those items happen to see where cuts can be made in the budget.

Summer Maintenance Projects:

- a. SMS Masonry Work Will start the week of June 22.
- b. Phones Should be installed in late June/early July.
- c. A roof ladder for the 3rd story HS roof: field measurements have been completed.
- d. HS blacktop sealing coating: Should start the week of June 22
- e. North School parking lot: Should start the week of June 22.

- f. Fix drywall at North: This work has begun and should be completed by the end of June.
- g. We also have some HLS items to take care of this summer.
 - i. Fire Shutters: They have begun some work, but waiting on shutters to be manufactured and delivered.
 - ii. Installing moisture proof lights in both shower rooms.
 - iii. Doors: I was able to get approval from ISBE to not install the door at North School due to its age and egress possibilities. However, I have ordered the two doors for the HS cost is \$6545.00 (HLS Funds)
 - iv. Replace fire pull stations in the HS \$1512 (HLS Funds)

The Governor signed a bill into law allowing for Election Day (this year only) to be a state holiday. Our hope was that we could waive it, unfortunately, the law amended the Election Code and not the School Code. ISBE legal is looking into it and should have a response soon.

Plan for PROM. NHS will just hold the Coronation on July 25 as planned. After that the Post-Prom Committee can take over to hold a dance/post-prom at a location of their choice, except on district property. We will provide them with some of the decoration and picture set at no cost.
